CONSENT ORDER

The Virginia Board of Nursing ("Board") and Ariel Dorsey, L.P.N., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Dorsey's license to practice practical nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Ariel Dorsey, L.P.N., was issued License No. 0002-086019 to practice practical nursing by the Virginia Board of Nursing on November 2, 2011. Said license is set to expire on June 30, 2015. Ms. Dorsey currently holds License No. 26NP06789100 to practice practical nursing in New Jersey. Ms. Dorsey's primary state of residence is Maryland.
2. On her August 27, 2011, application for licensure by examination as a practical nurse:
 - a. Ms. Dorsey answered NO to the question asking if she had applied for licensure as a practical nurse in another state although Ms. Dorsey had previously applied for licensure as a practical nurse in the state of Pennsylvania.
 - b. Ms. Dorsey answered NO to the question asking if she had ever been convicted, pled guilty to, or pled *nolo contendere* to the violation of any federal, state, or other statute or ordinance constituting a felony or misdemeanor. On May 11, 2010, Ms. Dorsey was convicted in the Bordentown Township, New Jersey, Criminal Court of one count of "resisting arrest – disorderly."

CONCLUSIONS OF LAW

Finding of Fact No. 3(a) and 3(b) constitute violations of § 54.1-3007(1) and (5) of the Code and 18 VAC 90-20-300(A)(1)(b) of the Regulations Governing the Practice of Nursing.

CONSENT

Ariel Dorsey, L.P.N., by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusion of Law contained herein and waives her right to contest such Findings of Fact and Conclusion of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her right to practice practical nursing in Virginia.

ORDER


WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. Ariel Dorsey, L.P.N., is hereby REPRIMANDED.

2. Ms. Dorsey shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.




