The Virginia Board of Nursing ("Board") and Zambia R. Player, C.N.A., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Player's application for licensure by endorsement to practice as a professional nurse in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Zambia R. Player, C.N.A., was issued Certificate No. 1401-144244 to practice as a nurse aide by the Virginia Board of Nursing on May 6, 2011. Said certificate expired on May 31, 2013. By Consent Order entered on January 28, 2011, Ms. Player was approved for certification and reprimanded due to the 2006 misdemeanor convictions for embezzlement referenced below.
- 2. Ms. Player holds License No. 1-135891 to practice professional nursing in the State of Alabama, which expires on December 31, 2014. By Consent Order of the Alabama Board of Nursing entered on March 16, 2012, Ms. Player was reprimanded due to the 2006 misdemeanor convictions for embezzlement, and she was required to provide all health care employers, collaborative physicians and schools of nursing with a copy of the Order.
- 3. By application received February 19, 2014, Ms. Player applied for licensure by endorsement to practice as a professional nurse in the Commonwealth of Virginia. She declared Alabama as her primary state of residence.
- 4. On October 13, 2006, in the General District Court of Newport News, Virginia, Ms. Player was convicted of two counts of misdemeanor embezzlement. All fines and court costs have been paid.

5. No further disciplinary action has been taken against Ms. Player since she was certified to practice as a nurse in Virginia or since she was licensed to practice professional nursing in Alabama.

CONCLUSIONS OF LAW

- 1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(7) of the Code of Virginia (1950), as amended ("Code").
 - 2. Finding of Fact No. 4 constitutes a violation of § 54.1-3007(4) of the Code.
 - 2. Ms. Player otherwise meets the requirements of §§ 54.1-3017 and 54.1-3018 of the Code.

CONSENT

Zambia R. Player, C.N.A., by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her application for licensure by endorsement to practice as a professional nurse in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The application of Zambia R. Player, C.N.A., for licensure by endorsement to practice as a professional nurse is APPROVED. Ms. Player shall be issued an unrestricted, single-state license to practice as a professional nurse in the Commonwealth.
 - 2. Ms. Player is hereby REPRIMANDED.
- 3. Ms. Player shall maintain a course of conduct in her capacity as a professional nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Regulations Governing the Practice of Nursing.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Consent Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
