ORDER

Now comes the Virginia Board of Nursing ("Board") and Jeffrey Lucas, R.N., as evidenced by the signature affixed below, enter into this Order affecting the license of Mr. Lucas to practice professional nursing in the Commonwealth of Virginia.

FINDINGS OF FACT

After consideration of the evidence and statements concerning the allegations, the Committee makes the following Findings of Fact:

1. Jeffrey Lucas, R.N., was issued License No. 0001-192187 to practice as a professional nurse in the Commonwealth of Virginia. Said license expired on September 29, 2010, due to his Nurse Licensure Compact and Mr. Lucas changing his primary state of residence to Maryland.
2. By Order entered December 19, 2008, Mr. Lucas was made subject to certain terms and conditions. One of the terms of this Order was Mr. Lucas' compliance with all terms and conditions of his contract with the Health Practitioners' Monitoring Program ("HPMP"), pursuant to Chapter 25.1 of Title 54.1 of the Code of Virginia (1950), as amended, and 18 VAC 76-10-10, et seq., of the Regulations Governing the HPMP.
3. Mr. Lucas has complied with all terms and conditions of the above Order; and has successfully completed his contract with the HPMP.

CONCLUSIONS OF LAW

The Board concludes that Jeffrey Lucas, R.N., has met the requirements of the Code of Virginia (1950), as amended, and the Regulations of the Board of Nursing, and the Order entered December 19,

2008, and this matter is properly before the Board.


ORDER

WHEREFORE, on the basis of the foregoing Findings of Fact and Conclusions of Law it is hereby ORDERED that the terms and conditions placed on the license of Jeffrey Lucas, R.N., to practice as a professional nurse in the Commonwealth of Virginia, be, and are hereby, TERMINATED.

Pursuant to § 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection or copying on request.

Pursuant to § 54.1-2400(10) of the Code, Mr. Lucas may, not later than 5:00 p.m., on March 27, 2014, notify Jay P. Douglas, Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that he desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
