**NOTICE OF HEARING**

Pursuant to §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended (“Code”), Robin Hensley, R.N., who, prior to its suspension by the Board of Nursing on June 3, 2014, held License No. 0001-213485 to practice professional nursing, is hereby given notice that a formal administrative hearing will be held in the presence of a panel of the Board of Nursing. The hearing will be held on July 17, 2014, at 1:30 p.m., at the offices of the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233, at which time Ms. Hensley will be afforded the opportunity to be heard in person or by counsel.


At the hearing, Ms. Hensley has the following rights, among others: the right to representation by counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Hensley desires any witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the Instructions for Requesting Subpoenas.

The purpose of the hearing is to inquire into evidence that Ms. Hensley may have violated certain laws governing the practice of professional nursing and certain terms and conditions imposed on her as set forth in the Order of the Board entered on October 3, 2013 (“Board’s Order”), as more fully set forth in the Statement of Particulars below.

**STATEMENT OF PARTICULARS**

The Board alleges that Robin Hensley, R.N., may have violated § 54.1-3007(6) of the Code and Term 5(a) of the Board’s Order, which required her to comply with all terms and conditions of the Health Practitioners’ Monitoring Program (“HPMP”) for the period specified by the HPMP, in that on or about May 16, 2014, she was dismissed from the HPMP for non-compliance with her program contract. Specifically, Ms. Hensley entered into a Participation Contract on or about December 12, 2013, and a Recovery Monitoring Contract on or about March 10, 2014. On or about March 19, 2014, Ms. Hensley missed calling into the screening test line, and she stopped calling the screening test line on or about April 3, 2014. On or about March 26, 2014, Ms. Hensley tested positive for alcohol. Following the positive test for alcohol, Ms. Hensley was required to attend 90 12-Step meetings in 90 days, submit a letter regarding what recovery meant to her, and enter into an intensive outpatient program by April 10, 2014. On or about April 10, 2014, Ms. Hensley submitted a letter of resignation to the HPMP.
