AMENDED ORDER

Pursuant to §§ 2.2-4019 and 2.2-4021 of the Code of Virginia (1950), as amended ("Code"), a Special Conference Committee of the Board of Nursing met on April 19, 2006, in Henrico County, Virginia, to receive and act upon the petition of Karen G. Temple, R.N., who holds License No. 0001-142010 to practice professional nursing in the Commonwealth of Virginia, for modification of the terms and conditions of probation as set forth in the Order entered by the Board on May 16, 2005. Ms. Temple was not present and was not represented by counsel.

WHEREFORE, upon consideration of the evidence presented, the Committee hereby ORDERS that Term No. 5 of the Order entered May 16, 2005, shall be amended as follows:


5. Ms. Temple shall practice nursing only in an employment setting satisfactory to her contract with HPIP.

All other terms of the Order entered May 16, 2005, shall remain in effect.


This order shall be applicable to Ms. Temple's multistate licensure privileges, if any, to practice professional nursing in the Commonwealth of Virginia. It is further ordered that for the duration of this Order, Ms. Temple may not work outside of the Commonwealth of Virginia pursuant to a multistate licensure privilege without the written permission of the Virginia Board of Nursing and the Board of Nursing in the party state where the respondent wishes to work. Any requests for out of state employment should be directed, in writing, to the Executive Director of the Board.

If Ms. Temple does not consent to the Committee’s decision and desires a hearing before the Board or a panel thereof, she shall notify, in writing, Jay P. Douglas, R.N., M.S.M., C.S.A.C., Executive Director, Board of Nursing, 6603 W. Broad Street, Fifth Floor, Richmond, Virginia 23230-1712 within thirty-three (33) days from the date of entry of this Order. This Order shall become final upon the expiration of the thirty-three (33) day period unless a written request for a formal hearing is received within such time. Upon receiving timely request for a hearing, the Board or panel thereof shall then proceed with a hearing as provided in §§ 2.2-4020 and 2.2-4021 of the Code.


