IN RE: KRISS LENDINI P. FAT, C.M.T. APPLICANT

CONSENT ORDER

The Virginia Board of Nursing ("Board") and Kriss Lendini P. Fat, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Fat's application for certification as a massage therapist in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. By application received February 6, 2014, Kriss Lendini P. Fat applied for certification by examination as a massage therapist in the Commonwealth of Virginia.
2. On July 28, 2009, Ms. Fat was convicted in the Circuit Court for Henrico County, Virginia, of two counts of use of identifying information to defraud, resulting in a financial loss greater than two hundred dollars, both felonies. On September 23, 2009, she was sentenced to four years incarceration with 3 years, 11 months and 15 days suspended for a period of 10 years. She was also ordered to pay \$3,322.45 in restitution and costs of \$780.00. She has paid all restitution and costs.
3. On January 9, 2014, Ms. Fat passed the Massage & Bodywork Licensing Examination ("MBLEx").

CONCLUSIONS OF LAW

The Board concludes that:

1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").

2. Ms. Fat otherwise meets the requirements of § 54.1-3029 of the Code.

CONSENT

Kriss Lendini P. Fat, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her application for certification to practice as a massage therapist in Virginia.

ORDER


WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. The application of Kriss Lendini P. Fat for certification to practice as a massage therapist is hereby APPROVED. Ms. Fat shall be issued an unrestricted certification to practice as a massage therapist in the Commonwealth of Virginia.
2. Kriss Lendini P. Fat is hereby REPRIMANDED.

3. Ms. Fat shall maintain a course of conduct in her capacity as a massage therapist commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.





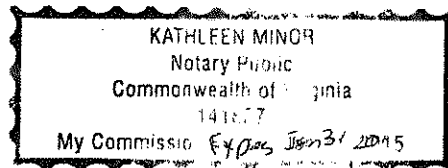
