CONSENT ORDER

The Virginia Board of Nursing ("Board") and Cy W. Black, C.N.A., as evidenced by his signature hereto, enter into the following Consent Order affecting Mr. Black's certificate to practice as a nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Cy W. Black, C.N.A. was issued Certificate No. 1401-135200 to practice as a nurse aide by the Virginia Board of Nursing on February 23, 2010. Said certificate is set to expire on February 28, 2015.
- 2. On Mr. Black's application for nurse aide certification by endorsement signed February 12, 2010, he answered "No" to the question asking him if he had "ever been convicted [or] pled guilty to . . . the violation of any federal, state, or other law constituting a felony or misdemeanor" when he was convicted on September 18, 2003, in the General District Court of Culpeper County, Virginia, of one count of driving under the influence, a misdemeanor, and on August 19, 2005, he was convicted in Prince William County, Virginia, for intoxication in public.

CONCLUSIONS OF LAW

Finding of Fact No. 2 constitutes a violation of § 54.1-3007(1) of the Code of Virginia (1950), as amended ("Code"), and 18 VAC 90-25-100(1)(b) of the Regulations Governing Certified Nurse Aides ("Regulations").

CONSENT

Cy W. Black, C.N.A., by affixing his signature hereon, agrees to the following:

- 1. He has been advised to seek advice of counsel prior to signing this document;
- 2. He acknowledges that without his consent, no legal action can be taken against him except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. He acknowledges that he has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against him;
 - 4. He waives all such right to an informal conference;
- 5. He admits to the Findings of Fact and Conclusions of Law contained herein and waives his right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. He consents to the entry of the following Order affecting his right to practice as a nurse aide in Virginia.

<u>ORDER</u>

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. Cy W. Black, C.N.A. is hereby REPRIMANDED.
- 2. Mr. Black shall maintain a course of conduct in his capacity as a nurse aide commensurate with the requirements of § 54.1-3000 *et seq*. of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
