**CONSENT ORDER**

The Virginia Board of Nursing ("Board") and Tiffany L. Deel, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Deel's application for licensure by examination to practice as a professional nurse in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

**FINDINGS OF FACT**

1. By application received November 2, 2013, Tiffany L. Deel applied for licensure by examination as a professional nurse in the Commonwealth of Virginia. She declared Virginia as her primary state of residence.
2. On February 21, 2008, in the Roanoke City General District Court, Roanoke, Virginia, Ms. Deel was convicted of two counts of misdemeanor larceny. She was sentenced to 30 days in jail with 26 days suspended, on each count. She was also fined \$25.00 plus court fees for each count, which have been paid in full.
3. On October 21, 2009, in the Circuit Court for the City of Salem, Virginia, Ms. Deel was convicted of two counts of grand larceny and two counts of obtaining property by false pretenses, all felonies. She was sentenced to four years incarceration, suspended, placed on supervised probation for two years and ordered to pay \$1,465.00 in court costs. Ms. Deel completed payment of the court costs and was released from probation on September 16, 2011.

**CONCLUSIONS OF LAW**

1. Findings of Fact Nos. 2 and 3 constitute a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
2. Ms. Deel otherwise meets the requirements of § 54.1-3017 of the Code.

**CONSENT**

Tiffany L. Deel, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;

2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her application for licensure by examination to practice as a professional nurse in Virginia.


**ORDER**

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. The application of Tiffany L. Deel for licensure by examination to practice as a professional nurse is APPROVED. Upon successful completion of the NCLEX-RN examination, Ms. Deel shall be issued an unrestricted license to practice as a professional nurse in the Commonwealth.
2. Ms. Deel is hereby REPRIMANDED.
3. Ms. Deel shall maintain a course of conduct in her capacity as a professional nurse commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Regulations Governing the Practice of Nursing.



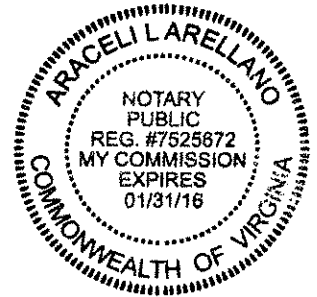
