CONSENT ORDER

The Virginia Board of Nursing ("Board") and Alisha V. Davis, R.M.A., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Davis' registration to practice as a medication aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Alisha V. Davis, R.M.A. was issued Registration No. 0031-004728 to practice as a medication aide by the Virginia Board of Nursing on January 18, 2011. Said registration is set to expire on June 30, 2014.

2. During the course of her employment as a medication aide at Virginia's Assisted Living Facility, Roanoke, Virginia, on March 3, 2013, Alisha V. Davis became upset with a resident. Ms. Davis handed the keys to the medication cart to the resident and left the building. She returned shortly afterwards and retrieved the keys from the resident. No medication was removed from the cart during the incident.

3. As a result of the incident, Ms. Davis was given a three day suspension.

CONCLUSIONS OF LAW

The Board concludes that Finding of Fact No. 2 constitutes a violation of § 54.1-3007(2) and (5) of the Code of Virginia (1950), as amended ("Code"), and 18 VAC 90-60-120(2)(f) of the Regulations Governing the Registration of Medication Aides.

CONSENT

Alisha V. Davis, R.M.A., by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her right to practice as a medication aide in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. Alisha V. Davis, R.M.A. is hereby REPRIMANDED.
2. Ms. Davis shall maintain a course of conduct in her capacity as a medication aide commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
