CONSENT ORDER

The Virginia Board of Nursing ("Board") and Phoebe Pegram, C.N.A., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Pegram's application for reinstatement of her certificate to practice as a nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Phoebe Pegram, C.N.A., was issued Certificate No. 1401-106304 to practice as a nurse aide by the Virginia Board of Nursing on October 22, 2004. Said certificate expired on November 9, 2012.
- 2. Ms. Pegram submitted an application for reinstatement of her certificate which was received by the Board on January 3, 2014.
- 3. On March 16, 2010, Ms. Pegram was convicted of felony grand larceny in the Circuit Court for Prince George County, Virginia. Ms. Pegram was sentenced to 10 years of incarceration, with the 10 years suspended.
- 4. Ms. Pegram provided evidence that she was released from supervised probation on July 5, 2011, but will remain on unsupervised probation for the remaining length of her suspended sentence.

CONCLUSIONS OF LAW

- 1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
- 2. Ms. Pegram otherwise meets the requirements for reinstatement of her certificate to practice as a nurse aide.

CONSENT

Phoebe Pegram, C.N.A., by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her application for reinstatement of her certificate to practice as a nurse aide in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The application of Phoebe Pegram for reinstatement of her certificate to practice as a nurse aide in the Commonwealth of Virginia is APPROVED.
 - 2. Ms. Pegram is hereby REPRIMANDED.
- 3. Ms. Pegram shall maintain a course of conduct in her capacity as a certified nurse aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
