NOTICE OF HEARING

Pursuant to §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended ("Code"), Cynthia Carroll-Hansbrough, L.P.N., who holds License No. 0002-069616 to practice practical

nursing in Virginia, which expires on November 30, 2015, is hereby given notice that a formal administrative

hearing will be held in the presence of a panel of the Board of Nursing. The hearing will be held on March

26, 2015, at 9:00 a.m., at the offices of the Department of Health Professions, Board of Nursing, Perimeter

Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233, at which time Ms. Carroll-Hansbrough

will be afforded the opportunity to be heard in person or by counsel.

At the hearing, Ms. Carroll-Hansbrough has the following rights, among others: the right to

representation by counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the

right to present documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Carroll-

Hansbrough desires any witnesses to appear on her behalf, she must notify the Director of Administrative

Proceedings, Department of Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in

accordance with the Instructions for Requesting Subpoenas.

The purpose of the hearing is to inquire into evidence that Ms. Carroll-Hansbrough may have

violated certain terms and conditions imposed on her as set forth in the Order of the Board entered on March

6, 2014 ("Board's Order"), and to inquire into evidence that Ms. Carroll-Hansbrough may have violated

certain laws governing nursing practice in Virginia, as more fully set forth in the Statement of Particulars

below.

STATEMENT OF PARTICULARS

The Board alleges that:

- 1. Cynthia Carroll-Hansbrough, L.P.N., may have violated Term 2 of the Board's Order entered March 6, 2014, which required her to comply with the terms and conditions of the Health Practitioners' Monitoring Program ("HPMP"). On July 18, 2014, Ms. Carroll-Hansbrough was dismissed from the HPMP due to noncompliance with her Recovery Monitoring Contract. Ms. Carroll-Hansbrough missed calling the drug testing line on May 7, 2014, and ceased calling the test line completely on May 28, 2014.
- 2. Ms. Carroll-Hansbrough may have violated § 54.1-3007(6) of the Code in that she may be unable to safely practice as a practical nurse due to mental illness. Ms. Carroll-Hansbrough's treating therapist opined that she is not safe to practice practical nursing based on her behavior during her last appointment with him.
