NOTICE OF INFORMAL CONFERENCE BEFORE AN AGENCY SUBORDINATE

Dear Ms. Carroll:

This letter is official notification that an informal conference of the Virginia Board of Nursing ("Board") will be held on **July 1, 2010, at 10:30 a.m.**, at the Department of Health Professions, Perimeter Center, 9960 Mayland Drive, Suite 201, Richmond, Virginia. In accordance with §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), this informal conference will be held before an agency subordinate of the Board of Nursing. This informal conference will be convened as a public meeting pursuant to § 2.2-3700 et seq. of the Code. The agency subordinate will inquire into allegations that you may have violated certain laws and regulations governing nursing practice in Virginia.

Specifically:

- 1. You may be in violation of § 54.1-3007(6) of the Code in that on or about March 24, 2009, during the course of your employment with Prince William Hospital, Manassas, Virginia, you submitted to a for-cause urine drug screen which was positive for marijuana.
- 2. You may have violated § 54.1-3007(2), (5), (6) and (8) of the Code and 18 VAC 90-20-300(A)(2)(c) of the Regulations Governing the Practice of Nursing in that during the course of your employment with Prince William Hospital:

- a. On or about March 6, 2009, at 1525 hours, you removed 1mg of Dilaudid (hydromorphone, Schedule II) from the Pyxis machine for Patient A. However, there was no documentation of administration or waste of said medication.
- b. On or about March 6, 2009, at 1644 hours, you removed 5mg of OxyIR (oxycodone, Schedule II) from the Pyxis machine for Patient B. However, there is no documentation of administration or waste of said medication.
- c. On or about March 6, 2009, at 1645 hours, you removed three tablets of Vicodin (hydrocodone, Schedule III) from the Pyxis machine for Patient B. However, there is no documentation of administration or waste of said medication.
- d. On or about March 23, 2009, at 1107 hours, you removed a 2mg syringe of Dilaudid from the Pyxis machine for Patient C. You documented administering said medication at 1110 hours, but deleted the documentation at 1132 hours. There is no documentation of waste of said medication.
- 3. You may have violated § 54.1-3007(5) and (8) of the Code in that during the course of your employment with Prince William Hospital:
- a. On or about March 6, 2009, Patient D had an order for .5mg of Dilaudid. You removed 1mg of Dilaudid from the Pyxis machine at 0810 hours and 1327 hours, and documented administration of 1mg of the medication.
 - b. On or about June 16, 2008, you transcribed an order on the wrong patient's chart.
- 4. You may have violated § 54.1-3007(5) of the Code in that during the course of your employment with Prince William Hospital, on or about February 23, 3009, Patient E had an order for .125mg of Xanax. You removed .25mg of Xanax from the Pyxis machine at 1030 hours and 1906 hours and documented administration of 0.125mg and waste of 0.125mg in the Pyxis machine. However, there was no documentation of administration in the patient's medication administration record.

In its deliberations, the agency subordinate may use the Sanction Reference Points System, as contained in the Sanction Reference Manual. The manual, which is a guidance document of the Board, may be accessed at http://www.dhp.virginia.gov/nursing. Please click on *Guidance Documents*, then select #90-7. You may also request a paper copy from the Board office by calling (804) 367-4515.

After consideration of all information, the agency subordinate may:

• If the agency subordinate finds that there is insufficient evidence to warrant further action or that the charges are without foundation, notify you by mail that your record has been cleared of any charge which might affect your right to practice nursing in the Commonwealth;

• Recommend findings of fact, conclusions of law and a sanction, to include a reprimand, placing you on probation with terms, suspension or revocation of your license, or imposing a monetary penalty pursuant to § 54.1-2401 of the Code.

Further, the agency subordinate may refer this matter for a formal administrative proceeding pursuant to § 2.2-4020 of the Code.

Since the allegations listed above involve impairment, please be advised that you may make application to the Health Practitioners' Monitoring Program ("HPMP"), which is available to all health care practitioners licensed in Virginia. Information about the HPMP is enclosed. Should you enter into a written agreement with the HPIP prior to your informal conference, the agency subordinate will take that into consideration when making a recommendation in your case.

Board's Review of Agency Subordinate's Recommended Decision

If you appear in person or by counsel at the informal conference, the recommendation of the agency subordinate will be presented to a quorum of the Board. The Board may accept or modify the recommendation, or reject the recommendation and move the case to formal hearing. If you do not agree with the decision of the Board, you have the right to a formal administrative hearing before the Board.

If you fail to appear in person or by counsel at the informal conference, the recommendation of the agency subordinate will be presented to a quorum of the Board. The Board may accept or modify the recommendation, or reject the recommendation. The Board's decision regarding the agency subordinate's recommendation is a final order that can only be appealed to circuit court as provided by Rule 2A:2 of the Supreme Court of Virginia.

You have the right to information that will be relied upon by the agency subordinate in making a decision. Therefore, I enclose a copy of the documents that will be distributed to the agency subordinate, and will be considered when discussing the allegations with you and when deliberating upon your case. These documents are enclosed only with the original notice sent by certified mail, which you may be required to claim at the post office. Please bring these documents with you to the informal conference.

To facilitate this proceeding, you should submit five copies of any documents you wish the agency subordinate to consider to the Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 300, Richmond, VA 23233, by June 25, 2010. Your documents may not be submitted by facsimile or email.

You may be represented by an attorney at the informal conference. If you obtain counsel, you should do so as soon as possible, because absent good cause to support a request for a continuance, the informal conference will be held on **July 1, 2010.** A request to continue this proceeding must state **in detail** the reason for the request and must establish good cause. Such request must be made, in writing, to me at the address listed on this letter and must be received by 12 noon on June 25, 2010. Only one such motion will be considered. Absent critical circumstances, such as personal or family illness, a request for a continuance after June 25, 2010, will not be considered.
