Pursuant to Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), you are hereby given notice that your license to practice nursing in the Commonwealth of Virginia has been mandatorily suspended by the enclosed Order entered February 21, 2014. You are hereby advised that, pursuant to Section 54.1-2409.1 of the Code, any person who practices a profession or occupation after having their license or certificate to do so suspended shall be guilty of a felony. Please return your license to Jay P. Douglas, Executive Director of the Virginia Board of Nursing, at the above address, immediately upon receipt of this letter.

Section 54.1-2409 of the Code further provides that you may apply to the Board of Nursing ("Board") for reinstatement of your license, and shall be entitled to a hearing not later than the next regular meeting of the Board after the expiration of sixty days from the receipt of such reinstatement application. You have the following rights, among others: to be represented by legal counsel, to have witnesses subpoenaed on your behalf, to present documentary evidence and to cross-examine adverse witnesses. The reinstatement of your license shall require the affirmative vote of three-fourths of the members present of the Board of Nursing.

I, Janet H. Brown, voluntarily surrender my Alaska Registered Nurse License number NUR R 30098 which was first issued to me on May 26, 2009 and has an expiration date of November 30, 2014.

I am surrendering my license at this time with the understanding that the Division of Corporations, Business and Professional Licensing is conducting an active investigation under case number 2013-001812 on behalf of the Alaska Board of Nursing, concerning allegations of falsification of an application by submitting a Registered Nurse License Biennial Renewal on October 22, 2012 which contained false information.

I understand that as a result of this surrender, I cannot practice as a Registered Nurse in the State of Alaska, and will not be able to do so until I have the approval of the Board. I further understand that before my license to practice as a Registered Nurse in Alaska can be reinstated, I will have to prove to the above Board that I am competent to resume practice, and am able to do so with skill and safety. If I make such request for reinstatement, and I am denied by the Board, I have the right to a Hearing, pursuant to AS 44.62, of the Administrative Procedure Act.

I am surrendering my license of my own free will. I am not under the influence of any medicine or other drugs that would affect my ability to think clearly and rationally. No promises or threats have been made to me by anyone to make me sign this document.
