NOTICE OF HEARING

Pursuant to §§2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended ("Code"), LeAnn Beverly, R.N., who holds License No. 0001-214900 which expires on June 30, 2013, is hereby given notice that a formal administrative hearing will be held in the presence of a panel of the Board of Nursing. The hearing will be held on Thursday, May 17, 2012, at 9:30 a.m., at the offices of the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233, at which time Ms. Beverly will be afforded the opportunity to be heard in person or by counsel.

At the hearing, Ms. Beverly has the following rights, among others: the right to representation by counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Beverly desires any witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the Instructions for Requesting Subpoenas.

The purpose of the hearing is to inquire into evidence that LeAnn Beverly, R.N., may have violated certain laws and regulations governing professional nursing practice in Virginia as more fully set forth in the Statement of Particulars below.

STATEMENT OF PARTICULARS

The Board alleges that:

- 1. Ms. Beverly may have violated §54.1-3007(2), (3), (5), and (8) of the Code and 18 VAC 90-20-300A(2)(b) and (f) of the Regulations Governing Professional Nursing ("Regulations") in that, during the course of her employment with Carilion Clinic Roanoke Memorial Hospital, Roanoke, Virginia:
- a. On or about February 17, 2011, by her own admission, she administered 60 mg of Lovenox (enoxaparin) by injection to Patient A without a physician's order. Furthermore, she failed to document the administration in Patient A's record, though she did report the error to her superior.
- b. On or about February 9, 2011, she failed to administer Patient B's 2:00 p.m. dose of heparin as ordered. She did not report this missed dose to Patient B's physician. By her own admission, Ms. Beverly advocated to the on-coming nurse to administer the patient's 2:00 p.m. dose at 5:00 p.m., stating that it could be given at that time. Ultimately, Patient B did not receive the 2:00 p.m. dose on that date.
- c. Also on or about February 9, 2011, by her own admission, she failed to document administration of Keppra (levetiracetam) at 3:00 p.m. to Patient C.
- d. On or about January 27, 2011, she failed to transfer Patient D in a timely manner following an ordered stat transfer to the intensive care unit for respiratory distress.
- 2. Ms. Beverly may have violated §54.1-3007(2), (3), (5), and (8) of the Code and 18 VAC 90-20-300A(2)(b), (e) and (f) of the Regulations in that during the course of her employment with Carilion Clinic Roanoke Memorial Hospital, on or about February 16, 2011, by her own admission, she discharged Patient E and indicated in his medical record that the patient left the unit with a hospital transport to his home on the same date. Patient E did not have a transport as Ms. Beverly had not yet arranged for one. In addition, she charted on February 16, 2011 at 7:52 p.m. that another nurse would be handling the discharge on the following day and had notified Patient E's physician, which was false.

3. Ms. Beverly may have violated §54.1-3007(2) and (5) of the Code and 18 VAC 90-20-300A(2)(m) of the Regulations in that also during the course of her employment with Carilion Clinic Roanoke Memorial Hospital, on or about February 16, 2011, while giving report on four individual patients, she allowed a hospital visitor to view confidential health information when she scrolled through patient records in full view of the visitor and verbalized their content.
