## **CONSENT ORDER**

The Virginia Board of Nursing ("Board") and Jessica Wood, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Wood's application for licensure by examination to practice practical nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

# **FINDINGS OF FACT**

- 1. By application received July 19, 2013, Jessica Wood applied for licensure by examination as a practical nurse in the Commonwealth of Virginia. Ms. Wood declared Virginia as her primary state of residence.
- 2. On March 25, 2009, in the Circuit Court of the City of Williamsburg and County of James City, Virginia, Ms. Wood was convicted of credit card theft and embezzlement, both felonies. The circuit court sentenced Ms. Wood to a total of ten years' imprisonment, with all but two months of imprisonment suspended for ten years. She was also ordered to pay court costs of \$1,335.00 and \$67.00 in restitution. Finally, the circuit court ordered her to undergo psychological counseling until released by her probation officer.
- 3. Ms. Wood submitted a letter from her probation officer dated November 12, 2013, in which her probation officer stated that Ms. Wood successfully completed the terms of her probation and paid all court ordered costs and restitution. A letter from Ms. Wood's counselor dated November 16, 2013, stated that Ms. Wood's successfully completed treatment several months after she was released from supervised probation.

### **CONCLUSIONS OF LAW**

- 1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(4) of the Code of Virginia, as amended ("Code").
  - 2. Ms. Wood otherwise meets the requirements of § 54.1-3020 of the Code.

### **CONSENT**

Jessica Wood, by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
  - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her application for licensure by examination to practice practical nursing in Virginia.

### **ORDER**

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- The application of Jessica Wood for licensure by examination as a practical nurse is 1. APPROVED. Upon successful completion of the NCLEX-PN examination, Ms. Wood shall be issued an unrestricted license to practice as a practical nurse in the Commonwealth.
  - 2. Ms. Wood is hereby REPRIMANDED.
- Ms. Wood shall maintain a course of conduct in her capacity as a practical nurse 3. commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Regulations Governing the Practice of Nursing.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Consent Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
