CONSENT ORDER

The Virginia Board of Nursing ("Board") and Daren J. Alexander, as evidenced by his signature hereto, enter into the following Consent Order affecting Mr. Alexander's application for registration by examination to practice as a medication aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law:

FINDINGS OF FACT

1. Daren J. Alexander submitted an application for registration by examination to practice as a medication aide which was received by the Board on June 20, 2013.
2. On August 23, 2013, Mr. Alexander was convicted of petit larceny in the Fairfax County, Virginia, General District Court.
3. Mr. Alexander provided evidence that he has established a payment agreement with the Court Debt Collections Office to pay his associated court costs and fines.

CONCLUSIONS OF LAW

1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
2. Mr. Alexander otherwise meets the qualifications of § 54.1-3042 of the Code.

CONSENT

Daren J. Alexander, by affixing his signature hereon, agrees to the following:

1. He has been advised to seek advice of counsel prior to signing this document;

2. He acknowledges that without his consent, no legal action can be taken against him except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. He acknowledges that he has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against him;
4. He waives all such right to an informal conference;
5. He admits to the Findings of Fact and Conclusions of Law contained herein and waives his right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. He consents to the entry of the following Order affecting his application for registration by examination to practice as a medication aide in Virginia.

ORDER

WHEREFORE, it is hereby ORDERED:

1. The application of Daren J. Alexander for registration by examination to practice as a medication aide is APPROVED. Upon successful completion of the Medication Aide examination, Mr. Alexander shall be issued an unrestricted registration to practice as a medication aide in the Commonwealth.
2. Mr. Alexander is hereby REPRIMANDED.
3. Mr. Alexander shall maintain a course of conduct in his capacity as a registered medication aide commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations Governing the Registration of Medication Aides.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
