## CONSENT ORDER

The Virginia Board of Nursing ("Board") and Donyetta Beall, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Beall's certificate to practice as a nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

### FINDINGS OF FACT

- Donyetta Beall was issued Certificate No. 1401-088121 to practice as a nurse aide by the 1. Virginia Board of Nursing on August 18, 2001. Said certificate expired on August 31, 2011.
- Ms. Beall submitted an application for reinstatement of her certificate, which was received by 2. the Board on November 1, 2013.
- 3. On October 7, 2010, in the City of Chesapeake, Virginia, Circuit Court, Ms. Beall was convicted of three counts of forging a public document, all felonies. She was sentenced to six years imprisonment, all suspended, and six months of probation, and ordered to pay fines and court costs totaling \$2,127.37.
- 4. Ms. Beall submitted evidence that she successfully completed her term of probation and paid the costs and fines associated with the above conviction.

## CONCLUSIONS OF LAW

Finding of Fact No. 3 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as 1. amended ("Code").

2. The Board concludes that Ms. Beall has demonstrated satisfactory evidence that she is prepared to resume practice in a safe and competent manner.

#### **CONSENT**

Donyetta Beall, by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
  - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her right to practice as a nurse aide in Virginia.

#### **ORDER**

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The certificate of Donyetta Beall to practice as a nurse aide in the Commonwealth of Virginia is hereby REINSTATED.
  - Ms. Beall is REPRIMANDED.

3. Ms. Beall shall maintain a course of conduct in her capacity as a nurse aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Regulations Governing Certified Nurse Aides.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
