<u>ORDER</u>

Pursuant to §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), a Special Conference Committee ("Committee") of the Virginia Board of Nursing ("Board") met on February 5, 2013, in Henrico County, Virginia, to inquire into evidence that Adedayo A. Faponle, R.N., may have violated certain terms and conditions imposed on his license to practice professional nursing in Virginia, as set forth in the Order of the Board entered on June 29, 2011. Mr. Faponle was present and was not represented by legal counsel. Upon consideration of the evidence, the Committee adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Adedayo A. Faponle, R.N., was issued License No. 0001-192781 to practice professional nursing in the Commonwealth of Virginia on September 21, 2004. Said license is valid in Virginia only and expires on October 31, 2014. Mr. Faponle also holds License No. 662807 to practice professional nursing in the State of New York. His primary state of residence is Maryland.
- 2. By letter dated January 8, 2013, the Board of Nursing sent a Notice of Informal Conference ("Notice") to Mr. Faponle notifying him that an informal conference would be held on February 5, 2013. The Notice was sent by certified and first class mail to 8806 Golden Tree Lane, Baltimore, Maryland 21221, the address of record on file with the Board of Nursing.
- 3. As of October 31, 2012, Mr. Faponle was employed and practicing as a professional nurse at Best Care Nursing and Residential, Inc., Pikeville, Maryland; however, he has not been approved to practice by the Maryland Board of Nursing.

CONCLUSIONS OF LAW

Finding of Fact No. 3 constitutes a violation of Term No. 2 of the Order entered June 29, 2011.

ORDER

On the basis of the foregoing, the Committee hereby ORDERS as follows:

- 1. Adedayo A. Faponle, R.N., is hereby REPRIMANDED.
- 2. Mr. Faponle is CONTINUED on PROBATION for a period of one year of actual nursing practice and subject to the terms and conditions of the Order entered June 29, 2011.
- 3. Mr. Faponle shall maintain a course of conduct in his capacity as a professional nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
- 4. Any violation of the terms and conditions of this Order or of any law or regulation affecting the practice of nursing in the Commonwealth of Virginia shall constitute grounds for the suspension or revocation of the license of Adedayo A. Faponle, R.N., and an administrative proceeding shall be convened to determine whether such license shall be suspended or revoked.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.

Pursuant to Section 54.1-2400(10) of the Code, Mr. Faponle may, not later than 5:00 p.m., on April 1, 2013, notify Jay P. Douglas, Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that he desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
