Pursuant to Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), you are hereby given notice that the privilege to renew your licenses to practice as a professional nurse and as a certified registered nurse anesthetist in the Commonwealth of Virginia have been mandatorily suspended by the enclosed Order entered December 12, 2013. You are hereby advised that, pursuant to Section 54.1-2409.1 of the Code, any person who practices a profession or occupation after having their license or certificate to do so suspended shall be guilty of a felony. Please return your licenses to Jay P. Douglas, Executive Director of the Board of Nursing, at the above address, immediately upon receipt of this letter.

Section 54.1-2409 of the Code further provides that you may apply to the Board of Nursing ("Board") for reinstatement of your licenses and shall be entitled to a hearing not later than the next regular meeting of the Board after the expiration of sixty days from the receipt of such reinstatement application. You have the following rights, among others: to be represented by legal counsel, to have witnesses subpoenaed on your behalf, to present documentary evidence and to cross-examine adverse witnesses. The reinstatement of your licenses shall require the affirmative vote of three-fourths of the members present of the Board of Nursing.

In accordance with Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), I. Diane L. Reynolds-Cane, M.D., Director of the Virginia Department of Health Professions, received and acted upon evidence that the license of Sandra Marie Rosado, R.N., C.R.N.A., to practice as a professional nurse and her license to practice as a certified registered nurse anesthetist in the State of Arkansas were suspended by an Order dated November 22, 2013. 

### FINDINGS OF FACT CONCLUSIONS OF LAW AND ORDER

A hearing on the captioned matter was held before the Arkansas State Board of Nursing (hereinafter referred to as "the Board"), on November 13, 2013, in the Board Room of the Arkansas State Board of Nursing, 1123 South University, Suite 800, Little Rock, Arkansas. The Board was represented by its General Counsel, William F. Knight. Sandra Marie Rosado, Registered Nurse and Certified Registered Nurse Anesthetist (hereinafter referred to as "Respondent"), failed to appear before the Board and was not represented by counsel. The Order and Notice of Hearing was mailed to Respondent on October 24, 2013. On the basis of testimony and other evidence presented, the Board made the following Findings of Fact, Conclusions of Law and Order.

#### FINDINGS OF FACT

- 1. On March 7, 2012, Respondent was found guilty of violating Ark. Code Ann. §17-87-309(a)(1), (a)(6) and (a)(7). Respondent was issued a Letter of Reprimand on March 7, 2012, and ordered to complete the Board-approved course, Righting a Wrong: Ethics and Professionalism in Nursing, within six (6) months of receipt of the Letter of Reprimand and submit a two (2) page summary of the course.
- 2. As of October 17, 2013, Respondent has failed to comply with the terms and conditions of the Board's March 7, 2012, Letter of Reprimand.

#### **CONCLUSIONS OF LAW**

- 1. Pursuant to Ark. Code Ann. §17-87-309, the Board has subject matter and personal jurisdiction in this matter.
- The Respondent has failed to comply with the terms and conditions of the Board's
   Letter of Reprimand of March 7, 2012.
- 3. The Respondent is guilty of violating the terms and conditions of the Letter of Reprimand.

#### **ORDER**

IT IS THEREFORE ORDERED that the license and privilege to practice issued to the Respondent be SUSPENDED until the terms of the Letter of Reprimand are met.

Respondent may request judicial review of the decision rendered by the Board by filing a petition in the circuit court of any county in which Respondent resides or does business or in the Circuit Court of Pulaski County within thirty (30) days after service upon Respondent of the Board's final decision.

Dear Ms. Rosado:

The Arkansas State Board of Nursing has received a complaint regarding your nursing practice. This Letter of Reprimand is being issued to Sandra Marie Rosado (hereinafter referred to as Respondent) for violations of the *Nurse Practice Act*.

The Nurse Practice Act of the State of Arkansas, A.C.A. §17-87-309 (Amended 1999) and Arkansas State Board of Nursing Rules Chapter 7, Section IV state:

- (a) The board shall have sole authority to deny, suspend, revoke or limit any license to practice nursing or certificate of prescriptive authority issued by the board or applied for in accordance with the provisions of this chapter or to otherwise discipline a licensee upon proof that the person:
- (1) Is guilty of fraud or deceit in procuring or attempting to procure a license to practice nursing.
  - False representation of facts on an... application for renewal of license;
- (6) Is guilty of unprofessional conduct;
  - Any other conduct that, in the opinon of the Board, is likely to deceive, degraud, injure or harm a patient or the public by an act, practice, or omission that fails to conform to the accepted standards of the nursing profession.
- (7) Has had a license, privilege to practice, certificate, or registration revoked or suspended or has been placed on probation or under disciplinary order in any jurisdiction.
- On March 16, 2011 Respondent completed on line applications for license renewal to renew her RN and CRNA licenses.
- On both applications Respondent answered "No" to the question "Are you under investigation in any state or jurisdiction or has your license been disciplined by any state since your last renewal."

- On September 15, 2010, the Nevada Board of Nursing disciplined Respondent's licenses for submitting "a RN/CRNA renewal application to the Board attesting that she completed all mandatory continuing education (CE) during the renewal period. A random CE audit demonstrated she did not complete the mandatory bioterrorism course during the renewal period being audited."
- Respondent falsified her Arkansas Nursing License Renewal Applications by failing to report
  the disciplinary action taken by the Nevada Board of Nursing.
- In addition on January 9, 2012 the North Carolina Board of Nursing issued a Letter of Reprimand for answering "No" to the question regarding disciplinary action in another state on her North Carolina nursing license renewal application that was submitted on September 21, 2011.

The Arkansas State Board of Nursing therefore Orders that the license of Sandra Marie Rosado is reprimanded and the following conditions are to be met:

Respondent is to provide evidence of completion of the Board approved course Righting a Wrong: Ethics and Professionalism in Nursing. The course is to be completed within six months of receipt of this Letter of Reprimand. Upon completion of the course Respondent is to submit a two-page summary as specified in the directions for Board Ordered Courses.

This letter of reprimand is:

- public information
- · made a part of your record
- scheduled to be reported in the ASBN newsletter following the disciplinary hearings
- reported to the National Council of State Boards of Nursing Disciplinary Data Bank and
- reported to the Healthcare Integrity and Protection Data Bank

You should understand that evidence of a prior violation of the Nurse Practice Act may be used for purposes of determining sanctions in any future disciplinary matters.

You may request a hearing before the full Board in lieu of this Letter of Reprimand. You have thirty (30) days upon receipt of this letter to request a formal hearing before the Arkansas State Board of Nursing.

You are responsible and accountable for your own practice. Please review the enclosed Grounds for Discipline.
