NOTICE OF INFORMAL CONFERENCE BEFORE AN AGENCY SUBORDINATE

Dear Ms. Lamb:

This letter is official notification that an informal conference of the Virginia Board of Nursing ("Board") will be held on **August 27, 2013, at 9:00 a.m.**, at the Department of Health Professions, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia. In accordance with §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), this informal conference will be held before an agency subordinate of the Board of Nursing. This informal conference will be convened as a public meeting pursuant to § 2.2-3700 *et seq.* of the Code. The agency subordinate will inquire into allegations that you may have violated certain laws and regulations governing practical nursing practice in Virginia.

Specifically:

- I. During the course of your employment with Golden Living Center, Charlottesville, Virginia:
 - a. You may have violated § 54.1-3007(2), (5), (6), and (8) of the Code and 18 VAC 90-20-300(A)(2)(c), (e), and (f) of the Regulations Governing the Practice of Nursing ("Regulations") in that, from in or about January 2013, to on or about May 16, 2013, you diverted narcotics for your personal and unauthorized use as evidenced by the following:
 - i. On or about April 27 and 28, 2013, you documented withdrawing four dosage units of oxycodone from Resident A's stock; however, you failed to administer the medication.
 - ii. On or about April 26, 2013, you documented withdrawing two dosage units of hydrocodone from Resident B's stock; however, he was not in the facility.
 - iii. On or about April 24 and 25, 2013, you forged another nurse's initials and withdrew oxycodone and hydrocodone from Residents C, D, and E's stock, and failed to administer the medications.

iv. From on or about April 10, 2013, to April 24, 2013, you documented withdrawing 34 dosage units of oxycodone from Resident F's stock and 16 dosage units of oxycodone from Resident G's stock and failed to administer the medications.

b. You may have violated § 54.1-3007(2), (5), (6), and (8) of the Code and 18 VAC 90-20-300(A)(2)(c) and (f) of the Regulations in that:

i. On or about March 18 and 26, 2013, you placed two orders for 60 dosage units of oxycodone for Resident G, even though the resident was not administered oxycodone every day. Further, when the medication was delivered by the pharmacy, you failed to add it to the narcotic count sheet.

ii. In or about January 2013, you diverted oxycodone, hydromorphone, and methadone from the stock of multiple residents and altered and/or destroyed the narcotic sheets.

2. You may have violated § 54.1-3007(6) of the Code in that you may be unable to safely practice practical nursing due to substance abuse and mental and/or physical illness which requires medication and treatment.

3. You may have violated § 54.1-3007(4) of the Code in that, on or about November 8, 2007, in the General District Court of Albemarle County, Virginia, you were convicted of misdemeanor larceny.

In its deliberations, the agency subordinate may use the Sanction Reference Points System, as contained in the Sanction Reference Manual. The manual, which is a guidance document of the Board, may be accessed at <http://www.dhp.virginia.gov/nursing>. Please click on *Guidance Documents*, then select #90-7. You may also request a paper copy from the Board office by calling (804) 367-4515.

After consideration of all information, the agency subordinate may:

- If the agency subordinate finds that there is insufficient evidence to warrant further action or that the charges are without foundation, notify you by mail that your record has been cleared of any charge which might affect your right to practice nursing in the Commonwealth;
- Recommend findings of fact, conclusions of law, and a sanction, to include a reprimand, placing you on probation with terms, suspension or revocation of your license, or imposing a monetary penalty pursuant to § 54.1-2401 of the Code.

Further, the agency subordinate may refer this matter for a formal administrative proceeding pursuant to § 2.2-4020 of the Code.

Board's Review of Agency Subordinate's Recommended Decision

If you **appear in person or by counsel at the informal conference**, the recommendation of the agency subordinate will be presented to a quorum of the Board. The Board may accept or modify the recommendation, or reject the recommendation and move the case to formal hearing. If you do not agree with the decision of the Board, you have the right to a formal administrative hearing before the Board.

If you **fail to appear in person or by counsel at the informal conference**, the recommendation of the agency subordinate will be presented to a quorum of the Board. The Board may accept or modify the recommendation, or reject the recommendation. The Board's decision regarding the agency subordinate's recommendation is a final order that can only be appealed to circuit court as provided by Rule 2A:2 of the Supreme Court of Virginia.

You have the right to information that will be relied upon by the agency subordinate in making a decision. Therefore, I enclose a copy of the documents that will be distributed to the agency subordinate, and will be considered when discussing the allegations with you and when deliberating upon your case. **These documents are enclosed only with the original notice sent by certified mail, which you may be required to claim at the post office. Please bring these documents with you to the informal conference.**


To facilitate this proceeding, you should submit five copies of any documents you wish the agency subordinate to consider to the Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 300, Richmond, VA 23233, by August 20, 2013. Your documents may not be submitted by facsimile or email.

You may be represented by an attorney at the informal conference. If you obtain counsel, you should do so as soon as possible, because absent good cause to support a request for a continuance, the informal conference will be held on August 27, 2013. A request to continue this proceeding must state **in detail** the reason for the request and must establish good cause. Such request must be made, in writing, to me at the address listed on this letter and must be received by 12 noon on August 20, 2013. Only one such motion will be considered. Absent critical circumstances, such as personal or family illness, a request for a continuance after August 20, 2013, will not be considered.
