ORDER

In accordance with §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), an informal conference was conducted on behalf of the Board of Nursing ("Board") on October 16, 2013, in Henrico County, Virginia. Trena S. Boudreaux, R.N., was present and was represented by Ross Allen, Esquire. Janet B. Younger, Ph.D., R.N., P.N.P., serving as Agency Subordinate for the Board, submitted a Recommended Decision for consideration.

On November 19, 2013, a quorum of the Board met to receive and act upon the Recommended Decision of the Agency Subordinate. Ms. Boudreaux was not present nor was she represented by legal counsel.

Based upon its review of the Recommended Decision of the Agency Subordinate, the Board makes the following Findings of Fact and Conclusions of Law and issues the following Order.

FINDINGS OF FACT

1. Trena S. Boudreaux, R.N., was issued License No. 0001-059031 to practice professional nursing in Virginia on August 18, 1975. The license is scheduled to expire on October 31, 2013. Her primary state of residence is Virginia.
2. By letter dated August 2, 2013, the Board of Nursing sent a Notice of Informal Conference ("Notice") to Ms. Boudreaux notifying her that an informal conference would be held on August 29, 2013. The Notice was sent by certified and first class mail to 458 Meadow Brook Lane, New Castle, Virginia 24127, the address of record on file with the Board of Nursing. Subsequently, Ms. Boudreaux requested a

continuance. By letter dated September 10, 2013, the Board notified Ms. Boudreaux that an informal conference would be held on October 16, 2013.

3. During the course of her employment as a school nurse with Craig County Schools, New Castle, Virginia, between 2009 and February 2013, Ms. Boudreaux obtained blood samples from numerous students via finger sticks to check their blood glucose levels, without a physician's order.

4. Ms. Boudreaux resigned her employment in May 2013, in lieu of termination.

CONCLUSIONS OF LAW

Finding of Fact No. 3 constitutes a violation of § 54.1-3007(2) and (5) of the Code and 18 VAC 90-20-300(A)(2)(a) of the Regulations Governing the Practice of Nursing.

ORDER

WHEREFORE, it is hereby ORDERED as follows:

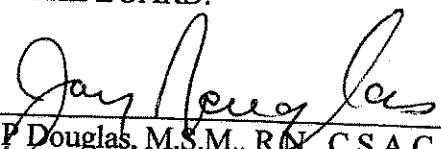
1. Trena S. Boudreaux, R.N., is hereby REPRIMANDED.

2. Ms. Boudreaux shall maintain a course of conduct in her capacity as a professional nurse commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Regulations Governing the Practice of Nursing.

Pursuant to § 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.

Pursuant to Section 54.1-2400(10) of the Code, Ms. Boudreaux may, not later than 5:00 p.m., on January 13, 2014, notify Jay P Douglas, M.S.M., R.N., C.S.A.C., F.R.E., Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that she desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
