NOTICE OF HEARING

Pursuant to §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended

("Code"), Anissa Watson, who, prior to its revocation by the Board of Nursing on August 16, 2010, held

Certificate No. 1401-067807, is hereby given notice that a formal administrative hearing will be held in the

presence of a panel of the Board of Nursing. The hearing will be held on November 21, 2013, at 11:00 a.m.,

at the offices of the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland

Drive, Suite 201, Henrico, Virginia 23233, at which time Ms. Watson will be afforded the opportunity to be

heard in person or by counsel.

At the hearing, Ms. Watson has the following rights, among others: the right to representation by

counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present

documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Watson desires any

witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of

Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the

Instructions for Requesting Subpoenas.

The purpose of the hearing is to receive and act upon Ms. Watson's application for reinstatement of

her certificate to practice as a nurse aide in Virginia and her petition for removal of a finding of neglect

based on a singular occurrence, pursuant to an Order entered August 16, 2010, and to inquire into allegations

that Ms. Watson may have violated certain laws and regulations governing nurse aide practice, as more fully

set forth in the Statement of Particulars, below.

The burden rests upon Ms. Watson, as the applicant/petitioner, to demonstrate that she is capable of resuming safe and competent nurse aide practice in Virginia and that her employment and personal history do not reflect a pattern of abusive behavior or neglect.

Pursuant to § 54.1-2408.2 of the Code, reinstatement of Ms. Watson's certificate requires the affirmative vote of three-fourths of the members of the Board in attendance at the hearing.

STATEMENT OF PARTICULARS

The Board alleges that Anissa Watson may have violated § 54.1-3007(2) of the Code and 18 VAC 90-25-100(2)(d) of the Regulations Governing the Certification of Nurse Aides in that on her application for employment with Tarboro Nursing Center, dated July 10, 2012, Ms. Watson failed to disclose that she had been employed by Personal Touch Home Care and Hospice, Newport News, Virginia, and that her employment was terminated in 2009 for falsifying time sheets.
