CONSENT ORDER

Pursuant to the terms and conditions of the April 20, 1990 Consent Order between Eunice E. Corbin, L.P.N. and the Virginia Board of Nursing, Eunice E. Corbin, L.P.N. appeared before the Special Conference Committee on October 9, 1990. Upon consideration of the evidence presented, the Board and Eunice E. Corbin, L.P.N., enter into this Consent Order.

FINDINGS OF FACT

- 1. By Consent Order entered April 20, 1990, the Licensed Practical Nurse license of Eunice E. Corbin was placed on indefinite probation due to abuse of controlled substances and alcohol, a copy of which is attached hereto and incorporated herein.
- 2. According to her statements to the Committee, Ms. Corbin has violated the terms and conditions of the Consent Order; specifically, #6 was violated in that she did not comply with the recommendations of her specialist, and #9 was violated in that she did not actively participate in Alcoholics Anonymous, Narcotics Anonymous and Caduceus.
- 3. Eunice E. Corbin agreed to voluntarily surrender her license to the Board and did so on or about October 18, 1990.

CONCLUSION OF LAW

Based upon the Findings of Fact, the Board concludes that Eunice E. Corbin, L.P.N. has not met the requirements of § 54.1-3009(C) of the Code of Virginia (1950), as amended.

CONSENT

Eunice E. Corbin, L.P.N. by affixing her signature hereon, agrees to the following:

- 1. She acknowledges that she has been specifically advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that she is fully aware that without her consent, no legal action can be taken against her, except pursuant to the Virginia Administrative Process Act, §9-6.14:1, et seq, of the Code of Virginia (1950), as amended;
- 3. She acknowledges that she has the following rights, among others: the right to a formal fact finding hearing before the Board, to reasonable notice of said hearing, to representation by counsel, and the right to cross examine witnesses against her;
 - 4. She waives all such rights to a formal hearing;
 - 5. She admits to the above Findings of Fact; and
- 6. She consents to the entry of the following Order affecting her license to practice practical nursing in the Commonwealth of Virginia.

ORDER

WHEREFORE, it is hereby ORDERED that the license of Eunice E. Corbin, L.P.N. to practice practical nursing in the Commonwealth of Virginia, be SUSPENDED until such time that Eunice E. Corbin can present clear and convincing evidence that

she is able to return to the practice of practical nursing in a safe and competent manner.

Pursuant to § 9-6.14:14 of the Code of Virginia (1950), as amended, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.
