**ORDER**

The Virginia Board of Nursing ("Board") adopts the following Findings of Fact and Conclusions of Law and issues the following Order regarding the application of Crystal L. Plogger for reinstatement of her license to practice practical nursing in Virginia.

**FINDINGS OF FACT**

1. Crystal L. Plogger was issued License No. 0002-052864 to practice practical nursing in the Commonwealth of Virginia on June 3, 1996. Said license was suspended by Order of the Board entered on February 7, 2011. Ms. Plogger's primary state of residence is Virginia.
2. Ms. Plogger submitted an application for reinstatement of her license to practice practical nursing, which was received by the Board on February 26, 2013.
3. By Order entered September 9, 2013, Ms. Plogger was ordered to have an evaluation by a mental health specialist satisfactory to the Board and have a written report of the evaluation, including a diagnosis, recommended course of therapy, prognosis, and any recommendations sent to the Board.
4. On October 11, 2013, the Board received a written report of an evaluation conducted by Associates in Brief Therapy, Inc., Roanoke, Virginia. The evaluator reported that Ms. Plogger does not present any symptoms of a mental illness or emotional disorder.

**CONCLUSIONS OF LAW**

1. This matter is properly before the Board.
2. The Board concludes that Crystal L. Plogger has demonstrated satisfactory evidence that she is prepared to resume practice in a safe and competent manner.


**ORDER**

WHEREFORE, the Virginia Board of Nursing, effective upon entry of this Order, hereby ORDERS that the license of Crystal L. Plogger to practice practical nursing in the Commonwealth of Virginia is hereby REINSTATED without restriction.

Ms. Plogger shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Regulations Governing the Practice of Nursing.
