CONSENT ORDER

The Virginia Board of Nursing ("Board") and Kimberly Vroegindewey, C.N.A., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Vroegindewey's certificate to practice as a nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Kimberly Vroegindewey, C.N.A., was issued Certificate No. 1401-155288 to practice as a nurse aide by the Virginia Board of Nursing on August 29, 2012. Said certificate is set to expire on August 31, 2014.
- 2. During the course of her employment with Mary Washington Healthcare, Stafford Hospital, Stafford, Virginia, on April 20, 2013, while assigned to provide one-to-one supervision to a suicidal patient, Ms. Vroegindewey fell asleep on duty.
 - 3. There was no harm to the patient.
- 4. Ms. Vroegindewey's employment with Mary Washington Healthcare was terminated on May 2, 2013, as a result of this incident.

CONCLUSIONS OF LAW

Finding of Fact No. 2 constitutes a violation of § 54.1-3007(5) of the Code of Virginia (1950), as amended ("Code").

CONSENT

Kimberly Vroegindewey, C.N.A., by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her right to practice as a nurse aide in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. Kimberly Vroegindewey, C.N.A., is hereby REPRIMANDED.
- 2. Ms. Vroegindewey shall maintain a course of conduct in her capacity as a nurse aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
