CONSENT ORDER

The Virginia Board of Nursing ("Board") and Randi D. Bradley, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Bradley's application for certification to practice massage therapy in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Randi D. Bradley submitted an application for certification to practice massage therapy in Virginia which was received by the Board on September 23, 2013. Ms. Bradley passed the MBLEX examination on July 26, 2013.
- 2. On January 19, 2010, in the Circuit Court of the City of Virginia Beach, Virginia, Ms. Bradley was convicted of felony obtaining welfare assistance under false pretenses. She was sentenced to three years' incarceration, all suspended, and ordered to pay court costs and \$19,108 in restitution to the Virginia Beach Department of Social Services.
- 3. Ms. Bradley provided evidence that she was making monthly restitution payments as required by the Court.

CONCLUSIONS OF LAW

- 1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended.
 - 2. Ms. Bradley otherwise meets the requirements of § 54.1-3029 of the Code.

CONSENT

Randi D. Bradley, by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document:
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her application for certification to practice massage therapy in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The application of Randi D. Bradley for certification to practice massage therapy in Virginia is APPROVED. Ms. Bradley shall be issued an unrestricted massage therapist certificate.
 - 2. Ms. Bradley is hereby REPRIMANDED.
- 3. Ms. Bradley shall maintain a course of conduct in her capacity as a certified massage therapist commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
