CONSENT ORDER

The Virginia Board of Nursing ("Board") and Delisa N. Turner, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Turner's application for certification by examination to practice as a nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. By application received June 6, 2013, Delisa N. Turner applied for certification by examination as a nurse aide in the Commonwealth of Virginia.
- 2. On February 26, 2010, in the General District Court of the City of Richmond, Virginia, Ms. Turner was convicted of misdemeanor larceny. She was sentenced to 90 days in jail with 60 days suspended, and placed on probation for two years. Ms. Turner was also ordered to pay fines and court costs totaling \$687.00, which were paid in full on August 20, 2010.
- 3. On August 5, 2009, in the General District Court of Henrico County, Virginia, Ms. Turner was convicted of misdemeanor larceny. She was sentenced to 12 months in jail, suspended, ordered to complete 20 hours of community service, and pay \$296.00 in fines and court costs, which were paid in full on August 18, 2009.

CONCLUSIONS OF LAW

- 1. Findings of Fact Nos. 2 and 3 constitute a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
 - 2. Ms. Turner otherwise meets the requirements of § 54.1-3023 of the Code.

CONSENT

Delisa N. Turner, by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her application for certification by examination to practice as a nurse aide in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The application of Delisa N. Turner for certification by examination as a nurse aide is APPROVED. Upon successful completion of the NNAAP examination, Ms. Turner shall be issued an unrestricted certificate to practice as a nurse aide in the Commonwealth.
 - 2. Ms. Turner is hereby REPRIMANDED.

3. Ms. Turner shall maintain a course of conduct in her capacity as a nurse aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Regulations Governing Certified Nurse Aides.
