CONSENT ORDER

The Virginia Board of Nursing ("Board") and Royce K. Quitoriano, as evidenced by his signature hereto, enter into the following Consent Order affecting Mr. Quitoriano's application for certification by examination to practice as a massage therapist in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. By application received March 29, 2013, Royce K. Quitoriano applied for certification by examination as a massage therapist in the Commonwealth of Virginia.
- 2. On January 10, 2013, Mr. Quitoriano successfully completed the National Certification Exam for Therapeutic Massage.
- 3. On July 23, 2004, in the Circuit Court of Stafford County, Virginia, Mr. Quitoriano was convicted of embezzlement, a felony. He was sentenced to three years imprisonment, suspended, and placed on supervised probation. Mr. Quitoriano was ordered to make restitution in the amount of \$7,497.00 and pay court costs of \$380.00.
- 4. On April 4, 2005, in the Circuit Court of the City of Fredericksburg, Virginia, Mr. Quitoriano was convicted of two counts of forging public records. He was sentenced to two years imprisonment on each charge, with one year and ten months suspended. Upon release from confinement, he was placed on supervised probation for an indefinite period of time and ordered to pay court costs totaling \$1550.00.

CONCLUSIONS OF LAW

1. Findings of Fact Nos. 3 and 4 constitute a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").

2. Mr. Quitoriano otherwise meets the requirements of § 54.1-3029 of the Code.

CONSENT

Royce K. Quitoriano, by affixing his signature hereon, agrees to the following:

- 1. He has been advised to seek advice of counsel prior to signing this document;
- 2. He acknowledges that without his consent, no legal action can be taken against him except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. He acknowledges that he has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against him;
 - 4. He waives all such right to an informal conference;
- 5. He admits to the Findings of Fact and Conclusions of Law contained herein and waives his right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. He consents to the entry of the following Order affecting his application for certification by examination to practice as a massage therapist in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The application of Royce K. Quitoriano for certification by examination as a massage therapist is APPROVED and Mr. Quitoriano shall be issued an unrestricted certificate to practice as a massage therapist in the Commonwealth.
 - Mr. Quitoriano is hereby REPRIMANDED.

3. Mr. Quitoriano shall maintain a course of conduct in his capacity as a massage therapist commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Regulations Governing the Certification of Massage Therapists.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
