CONSENT ORDER

The Virginia Board of Nursing ("Board") and Dana Allcock, R.N., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Allcock's license to practice professional nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Dana Allcock, R.N., was issued License No. 0001-142496 to practice professional nursing by the Virginia Board of Nursing on April 12, 1995. Said license is set to expire on January 31, 2015. Her primary state of residence is Virginia.
- 2. During the course of Ms. Allcock's employment at Centra Lynchburg General Hospital, Lynchburg, Virginia, she falsely documented that she obtained patient information. Specifically:
 - a. On October 17, 2012, Ms. Allcock documented that she obtained Patient A's arrival information, allergy list, patient education items, adherence to plan of care, visit discharge information, and plan of care details, prior to Patient A's arrival. When Patient A arrived, another nurse obtained Patient A's information.
 - b. On September 28, 2012, Ms. Allcock documented the she obtained Patient B's arrival information, allergy list, patient education items, lower extremity assessment, adherence to plan of care and pain assessment, when, in fact, Patient B never arrived for the scheduled appointment.
 - c. On July 13, 2012, at 0822 Ms. Allcock documented that she obtained Patient C's arrival information, when, in fact, Patient C arrived at 0850 and another nurse initiated the patient visit.

3. Centra Lynchburg General Hospital terminated Ms. Allcock's employment as a result of the false documentation.

CONCLUSIONS OF LAW

Finding of Fact No. 2 constitutes a violation of § 54.1-3007(2), (5), and (8) of the Code of Virginia (1950), as amended ("Code"), and 18 VAC 90-20-300(A)(2)(e) of the Regulations Governing the Practice of Nursing ("Regulations").

CONSENT

Dana Allcock, R.N., by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her right to practice professional nursing in Virginia.

<u>ORDER</u>

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. Dana Allcock, R.N., is hereby REPRIMANDED.

2. Ms. Allcock shall maintain a course of conduct in her capacity as a professional nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
