Dear Ms. Clancy:

Pursuant to Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), you are hereby given notice that your license to practice nursing in the Commonwealth of Virginia has been mandatorily suspended by the enclosed Order entered September 30, 2013. You are hereby advised that, pursuant to Section 54.1-2409.1 of the Code, any person who practices a profession or occupation after having their license or certificate to do so suspended shall be guilty of a felony. Please return your license to Jay P. Douglas, Executive Director of the Virginia Board of Nursing, at the above address, immediately upon receipt of this letter.

Section 54.1-2409 of the Code further provides that you may apply to the Board of Nursing ("Board") for reinstatement of your license, and shall be entitled to a hearing not later than the next regular meeting of the Board after the expiration of sixty days from the receipt of such reinstatement application. You have the following rights, among others: to be represented by legal counsel, to have witnesses subpoenaed on your behalf, to present documentary evidence and to cross-examine adverse witnesses. The reinstatement of your license shall require the affirmative vote of three-fourths of the members present of the Board of Nursing.


**ORDER**

In accordance with Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), I, Dianne L. Reynolds-Cane, M.D., Director of the Virginia Department of Health Professions, received and acted upon evidence that the license of Victoria Lee Clancy, L.P.N., to practice nursing in the State of Illinois was suspended by a Suspension Order dated April 1, 2013. A certified copy of the Suspension Order is attached to this Order and is marked as Commonwealth's Exhibit No. 1.

WHEREFORE, by the authority vested in the Director of the Department of Health Professions pursuant to Section 54.1-2409 of the Code, it is hereby ORDERED that the privilege of Victoria Lee Clancy, L.P.N., to renew her license to practice nursing in the Commonwealth of Virginia be, and hereby is, SUSPENDED.

Upon entry of this Order, the license of Victoria Lee Clancy, L.P.N., will be recorded as suspended and no longer current. Should Ms. Clancy seek reinstatement of her license pursuant to Section 54.1-2409 of the Code, she shall be responsible for any fees that may be required for the reinstatement and renewal of her license prior to issuance of her license to resume practice.

Pursuant to Sections 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection and copying upon request.



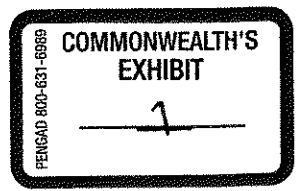

SUSPENSION ORDER

This matter having come before me on notice against Respondent, VICKY LEE CLANCY (HEREINAFTER REFERRED TO AS "Respondent") filed with the DIVISION OF PROFESSIONAL REGULATION of the DEPARTMENT OF FINANCIAL AND PROFESSIONAL REGULATION of the State of Illinois by the Illinois Department of Revenue including a certification, signed by the Director of the Department of Revenue or designee, attesting to an unpaid tax liability and/or that a return was not filed and being duly advised in the premises.

WHEREFORE, pursuant to 20 ILCS 2105/2105-15(g) and 68 Ill. Adm. Code 1100.560, it is hereby ordered, as follows:


- Respondent's Certificate of Registration as a LICENSED PRACTICAL NURSE, License No. 043.104928, be and is hereby SUSPENDED; Respondent shall immediately surrender said Certificate of Registration and all other indicia of licensure to the Department of Financial and Professional Regulation of the State of Illinois. Upon the failure to do so, the Department shall seize said Certificates of Registration;
- Enforcement of the terms and conditions of this Order shall be stayed for sixty (60) days from the date of this order.
