Dear Ms. Jones:

Pursuant to Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), you are hereby given notice that your license to practice nursing in the Commonwealth of Virginia has been mandatorily suspended by the enclosed Order entered May 31, 2012. You are hereby advised that, pursuant to Section 54.1-2409.1 of the Code, any person who practices a profession or occupation after having their license or certificate to do so suspended shall be guilty of a felony. Please return your license to Jay P. Douglas, Executive Director of the Virginia Board of Nursing, at the above address, immediately upon receipt of this letter.

Section 54.1-2409 of the Code further provides that you may apply to the Board of Nursing ("Board") for reinstatement of your license, and shall be entitled to a hearing not later than the next regular meeting of the Board after the expiration of sixty days from the receipt of such reinstatement application. You have the following rights, among others: to be represented by legal counsel, to have witnesses subpoenaed on your behalf, to present documentary evidence and to cross-examine adverse witnesses. The reinstatement of your license shall require the affirmative vote of three-fourths of the members present of the Board of Nursing.

The defendant came before the Court for sentencing and appeared in person with counsel, James L. Grandfield. The Commonwealth was represented by Marilyn A. Sallee.

On January 12, 2012, the Court found that the evidence was sufficient to find the defendant guilty of the following offense:

Offense Description and Indicator (F/M) and Code Section and Offense Date:

# OBTAIN PRESCRIPTION BY FRAUD (\$18.2-258.1, \$18.2-10) (FELONY) (OFFENSE DATE: 06-23-11) (VCC CODE: NAR-3016-F6)

The Court ordered finding withheld until today. The Court hereby finds the defendant guilty of Obtain Prescription Drugs by Fraud, as charged in the indictment.

The pre-sentence report was considered and is ordered filed as a part of the record in accordance with the provisions of Code § 19.2-299.

The Court has considered and reviewed the applicable discretionary sentencing guidelines and the guidelines worksheets, pursuant to the provisions of \$19.2-298.01. The sentencing guidelines worksheets and the written explanation of any departure from the guidelines are ordered filed as a part of the record.



Before pronouncing the sentence, the Court inquired if the defendant desired to make a statement and if the defendant desired to advance any reason why judgment should not be pronounced.

The Court SENTENCES the defendant to:

Incarceration with the Virginia Department of Corrections for the term of Five (5) Years.

This sentence shall run consecutively.

The Court SUSPENDS ALL of the Five (5) Year sentence, for a period of Three (3) Years, upon the following condition(s):

Good Behavior. The defendant shall be of good behavior for a period of Three (3) Years.

Supervised Probation. The defendant is placed on probation under the supervision of a Probation Officer for a period of Three (3) Years, or unless sooner released by the court or by the probation officer. The defendant shall comply with all the rules and requirements set by the probation officer. Probation shall include substance abuse counseling and/or testing as deemed necessary by the Probation Officer.

Costs. The defendant shall pay court costs, including attorney fees, if court appointed and any interest that may accrue until the balance is paid in full.

License Suspension. The Court suspends the defendant's motor vehicle operator's license for 6 Months; however, the defendant is granted a restricted operator's license.

DNA testing. The defendant shall submit to DNA testing pursuant to \$19.2-310.2 of the Virginia Code (1950), as amended.

**Credit for time served.** The defendant shall be given credit for time spent in confinement while awaiting trial pursuant to Code § 53.1-187.

Departure. The defendant is allowed to depart.
