CONSENT ORDER

The Virginia Board of Nursing ("Board") and Annette Bonner, L.P.N., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Bonner's license to practice practical nursing.

FINDINGS OF FACT

- 1. Annette Bonner, L.P.N., was issued License No. 0002-035045 to practice practical nursing by the Virginia Board of Nursing on November 30, 1984. Said license is set to expire on July 31, 2008.
- 2. On July 30, 2007, Ms. Bonner falsified her application for employment with Autumn Health Care by failing to indicate that her reason for leaving Beth Shalom Village, Virginia Beach, Virginia, was termination due to abandonment of her shift and other work performance issues.

CONCLUSIONS OF LAW

Finding of Fact No. 2 constitutes a violation of § 54.1-3007(2) and (5) of the Code of Virginia (1950), as amended ("Code"), and 18 VAC 90-20-300(A)(2)(e) of the Regulations Governing the Practice of Nursing.

CONSENT

Annette Bonner, L.P.N., by affixing her signature hereon, agrees to the following:

- 1. Ms. Bonner has been advised to seek advice of counsel prior to signing this document;
- 2. Ms. Bonner acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;

- 3. Ms. Bonner acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. Ms. Bonner waives all such right to an informal conference;
- 5. Ms. Bonner admits to the Findings of Fact contained herein and waives her right to contest such Findings of Fact in any subsequent proceeding before the Board;
- 6. Ms. Bonner consents to the entry of the following Order affecting her right to practice practical nursing in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. Annette Bonner is hereby REPRIMANDED.
- 2. Ms. Bonner shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3000 *et seq*. of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
