CONSENT ORDER

The Virginia Board of Nursing ("Board") and Katie Young, C.N.A., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Young's certificate to practice as a nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Katie Young, C.N.A., was issued Certificate No. 1401-134180 to practice as a nurse aide by the Virginia Board of Nursing on December 17, 2009. Said certificate is set to expire on December 31, 2013.
- 2. On February 6, 2013, the Board entered an Order taking no action against Ms. Young contingent upon her entry into and compliance with the Health Practitioners' Monitoring Program ("HPMP"). This was a result of Ms. Young's admission to CJW Medical Center, Tucker Pavilion, Richmond, Virginia ("Tucker Pavilion"), on May 31, 2012, and subsequent diagnoses of mood disorder, generalized anxiety disorder, and her admission to suffering from depression for approximately 16 years.
- 3. On February 25, 2013, Ms. Young entered into a Participation Contract with the HPMP. On March 31, 2013, Ms. Young was admitted to Tucker Pavilion, where she was diagnosed with a mood disorder and general anxiety disorder. On May 8, 2013, Ms. Young submitted a letter of resignation to the HPMP. As a result of her compliance with her Participation Contract, Ms. Young's resignation was accepted by the HPMP Program Committee and she was allowed to resign.

- 4. On June 19, 2013, Ms. Young returned her certificate to the Board with "voluntary surrender" written across the front.
- 5. On June 19, 2013, during a telephone interview with an investigator for the Department of Health Professions, Ms. Young stated that her anxiety is overwhelming and she has been unable to practice as a certified nurse aide since April 2012. Further, Ms. Young stated that she has no plans to return to practice as a nurse aide.

CONCLUSIONS OF LAW

Findings of Fact Nos. 3 and 5 constitute a violation of § 54.1-3007(6) of the Code of Virginia (1950), as amended ("Code").

CONSENT

Katie Young, C.N.A., by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her right to practice as a certified nurse aide in Virginia.

<u>ORDER</u>

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of

this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. The Board ACCEPTS the VOLUNTARY SURRENDER for INDEFINITE SUSPENSION of

Katie Young's certificate to practice as a nurse aide in the Commonwealth of Virginia.

2. The certificate will be recorded as suspended and no longer current.

3. At such time as Ms. Young shall petition the Board for reinstatement of her certificate, an

administrative proceeding will be convened to determine whether she is capable of resuming the safe and

competent practice as a nurse aide. Ms. Young shall be responsible for any fees that may be required for the

reinstatement and renewal of the certificate prior to issuance of the certificate to resume practice.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in

the custody of the Department of Health Professions as public record and shall be made available for public

inspection or copying upon request.
