ORDER

The Virginia Committee of the Joint Boards of Nursing and Medicine ("Committee of the Joint Boards") adopts the following Findings of Fact and Conclusions of Law and enters the following Order regarding the license of Jean M. Black, R.N., L.N.P., to practice as a nurse practitioner in Virginia.

FINDINGS OF FACT

1. Jean M. Black, R.N., L.N.P., was issued License No. 0024-101703 on January 3, 1992 to practice as a nurse practitioner by the Committee of the Joint Boards. Ms. Black was issued License No. 0017-000956 for prescriptive authority on July 23, 1996. Both licenses are set to expire on August 31, 2014.
2. By Order of the Committee of the Joint Boards entered on December 28, 2012, Ms. Black was reprimanded and placed on indefinite probation for not less than one year of active employment as a licensed nurse practitioner, with terms and conditions.
3. On February 8, 2013, the Committee of the Joint Boards approved Ms. Black's employment as a nurse practitioner at Tri-Area Community Health Center, Floyd, Virginia, under the onsite supervision of a physician.
4. Ms. Black has complied with the terms of the Order entered December 28, 2012.

CONCLUSIONS OF LAW

1. This matter is properly before the Committee of the Joint Boards.
2. Ms. Black has demonstrated satisfactory evidence to warrant release from probation.


ORDER

WHEREFORE, it is hereby ORDERED that the petition of Jean M. Black, R.N., L.N.P., for release from probation, is GRANTED and Ms. Black shall be issued an unrestricted license to practice as a nurse practitioner.

Ms. Black shall maintain a course of conduct in her capacity as a nurse practitioner commensurate with the requirements of § 54.1-2957 *et seq.* of the Code, the Regulations Governing the Licensure of Nurse Practitioners and the Regulations for Prescriptive Authority for Nurse Practitioners.


