## BEFORE THE BOARD OF NURSING

IN RE: SHEQUITA MITCHELL, C.N.A. APPLICANT

CONSENT ORDER

The Virginia Board of Nursing ("Board") and Shequita Mitchell, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Mitchell's application for certification by examination to practice as a nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Shequita Mitchell submitted an application for certification by examination to practice as a nurse aide which was received by the Board on June 20, 2013.
2. On June 26, 2000, Ms. Mitchell was convicted of distribution or possession with the intent to sell marijuana, a misdemeanor, in the Petersburg, Virginia, General District Court.
3. On July 26, 2011, Ms. Mitchell was convicted of grand larceny in the Circuit Court or the City of Colonial Heights, Virginia ("Colonial Heights Circuit Court"). She was sentenced to 20 years, suspended, and placed on supervised probation.
4. On September 21, 2012, the Colonial Heights Circuit Court approved termination of Ms. Mitchell's supervised probation.

CONCLUSIONS OF LAW

1. Findings of Fact No. 3 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
2. Otherwise, Ms. Mitchell meets the qualifications of § 54.1-3023 of the Code.

**CONSENT**

Shequita Mitchell, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her application for certification by examination to practice as a nurse aide in Virginia.

**ORDER**

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. The application of Shequita Mitchell for certification by examination to practice as a nurse aide is APPROVED. Upon successful completion of the NNAAP examination, Ms. Mitchell shall be issued an unrestricted certificate to practice as a nurse aide in the Commonwealth.
2. Ms. Mitchell is hereby REPRIMANDED.

3. Ms. Mitchell shall maintain a course of conduct in her capacity as a certified nurse aide commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.

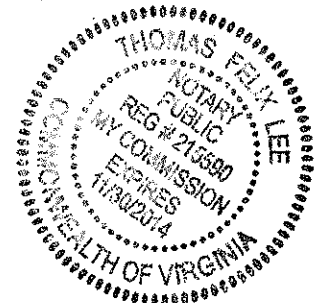
