Dear Ms. Woods:

This is official notification that an informal conference will be held pursuant to §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), on August 28, 2013, at 1:00 p.m., at the Department of Health Professions, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233. You may be represented by an attorney at the conference. This informal conference will be convened as a public meeting pursuant to § 2.2-3700 et seq. of the Code.

The Special Conference Committee ("Committee"), which is comprised of at least two members of the Virginia Board of Nursing ("Board"), will receive and act upon your application for the reinstatement of your license to practice professional nursing in the Commonwealth of Virginia, which was suspended by an Order of the Board entered September 30, 2008, and will inquire into allegations that you may have violated certain laws and regulations governing nursing practice in Virginia.

## Specifically:

- 1. You may have violated § 54.1-3007(4) of the Code in that on or about January 4, 2010, in the Circuit Court of Henrico County, Virginia, you were convicted of felony prescription fraud.
- 2. You may have violated § 54.1-3007(6) of the Code in that you may be unable to safely practice nursing due to substance abuse and/or mental illness, as evidenced by the following:
- a. Although you assert that your date of sobriety is July 25, 2009, you have continued to obtain large amounts of opiates and benzodiazepines from multiple practitioners since that time. In addition, you were hospitalized in March 2011 for an apparent overdose of fentanyl (Schedule II).

- b. You continued to obtain opiates from other providers, at numerous different pharmacies, despite signing a pain management contract with your primary care physician on July 29, 2009, in which you agreed not to do so.
- c. You falsely told your psychiatrist, who is treating you for bipolar disorder and post-traumatic stress disorder, and from whom you receive prescriptions for benzodiazepines, that you had not consumed any opiates since July 2009.
- d. You were hospitalized on or about May 9, 2010, for depression and suicidal ideation, along with seizures.
- e. You were hospitalized on or about May 28, 2010, relative to complaints of migraines and acute psychosis, which included auditory hallucinations directing you to harm yourself and others.
- 3. You may have violated § 54.1-3007(2) of the Code and 18 VAC 90-20-300(A)(2)(n) of the Regulations Governing the Practice of Nursing in that on or about February 14, 2013, you falsely told an investigator for the Department of Health Professions that you had not obtained any opiates since July 27, 2009.

The burden rests on you, as the applicant, to demonstrate that you are able to resume the safe and competent practice of professional nursing.

After the informal conference, the Committee is authorized by § 54.1-2400(10) of the Code to take any of the following actions:

- The Committee may reinstate your license to practice professional nursing in the Commonwealth without restriction;
- The Committee may reinstate your license and place you on probation for such time as it may designate and subject to such terms and conditions as it may deem appropriate, reprimand you, or impose a monetary penalty;
  - The Committee may deny your application for reinstatement of your license.

Further, the Committee may refer the case to the Board of Nursing or a panel thereof for a formal hearing.

If you fail to appear at the informal conference, the Committee may proceed to hear the case in your absence and may take any of the actions outlined above. At least ten days prior to the scheduled date of the conference, please inform this office at (804) 367-4515, or in writing at the address listed above, of your telephone number and whether you intend to appear at the informal conference.

To facilitate this proceeding, you should submit five copies of any documents you wish the Committee to consider to the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, by August 23, 2013. Your documents may not be submitted by facsimile or email.
