CONSENT ORDER

The Virginia Board of Nursing ("Board") and Jennifer Garnett, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Garnett's application for registration by examination as a medication aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Jennifer Garnett submitted an application for registration by examination as a medication in Virginia, which was received by the Board on July 8, 2013.
- 2. On December 14, 2011, Ms. Garnett was convicted in the Circuit Court of Fairfax County, Virginia, of embezzlement, a felony.
- 3. On March 26, 2012, Ms. Garnett was sentenced to four years' imprisonment with all but six months suspended. She was ordered to pay \$96,203.35 in restitution, of which she has paid \$1,000.00, and she was placed on probation for four years.

CONCLUSIONS OF LAW

- 1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(4) of the Code.
- 2. Ms. Garnett otherwise meets the requirements of § 54.1-3042 of the Code.

CONSENT

Jennifer Garnett, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;

- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her application for registration as a medication aide in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The application of Jennifer Garnett for registration by examination as medication aide is hereby APPROVED. Upon successful completion of the Medication Aide examination, Ms. Garnett shall be issued an unrestricted registration to practice as a medication aide in Virginia.
 - 2. Ms. Garnett is hereby REPRIMANDED.
- 3. Ms. Garnett shall maintain a course of conduct in her capacity as a medication aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
