Dear Ms. Jackson:

Pursuant to Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), you are hereby given notice that your certification to practice as a certified nurse aide in the Commonwealth of Virginia has been mandatorily suspended by the enclosed Order entered February 10, 2009. You are hereby advised that, pursuant to Section 54.1-2409.1 of the Code, any person who practices a profession or occupation after having their license or certificate to do so suspended shall be guilty of a felony. Please return your certificate to Jay P. Douglas, Executive Director, at the above address, immediately upon receipt of this letter.

Section 54.1-2409 of the Code further provides that you may apply to the Board of Nursing ("Board") for reinstatement of your certificate, and shall be entitled to a hearing not later than the next regular meeting of the Board after the expiration of sixty days from the receipt of such reinstatement application. You have the following rights, among others: to be represented by legal counsel, to have witnesses subpoenaed on your behalf, to present documentary evidence and to cross-examine adverse witnesses. The reinstatement of your certificate shall require the affirmative vote of three-fourths of the members present of the Board of Nursing.

<u>ORDER</u>

In accordance with Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), I, Emily O. Wingfield, Chief Deputy Director of the Virginia Department of Health Professions, received and acted upon evidence that Mynesha Aren Jackson, C.N.A., was convicted of felony charges in the Circuit Court of the County of Henrico for the Commonwealth of Virginia, to wit:

1. One (1) Count of Uttering a Forged Check;

2. One (1) Count of Grand Larceny; and

3. One (1) Count of Check Forgery.

A certified copy of the Sentencing Order is attached and is marked as Commonwealth's Exhibit No. 1.

WHEREFORE, by the authority vested in the Director of the Department of Health Professions pursuant to Section 54.1-2409 of the Code, it is hereby ORDERED that the certificate of Mynesha Aren Jackson, C.N.A., to practice as a certified nurse aide in the Commonwealth of Virginia be, and hereby is, SUSPENDED.

Upon entry of this Order, the certificate of Mynesha Aren Jackson, C.N.A., will be recorded as suspended and no longer current. Should Ms. Jackson seek reinstatement of her certificate pursuant to Section 54.1-2409 of the Code, she shall be responsible for any fees that may be required for the reinstatement and renewal of her certificate prior to issuance of her certificate to resume practice.

Pursuant to Sections 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection and copying upon request.

ORDER - CASE (S) NO. CR08-1815-00F

On July 1, 2008, came Paul Cushman, the attorney for the Commonwealth, and Mynesha Avon Jackson, born January 20, 1986, who stands indicted for three (3) felonies, to-wit: uttering a forged check (Virginia Code Section 18.2-172), in Case No. CR08-1815-00F, grand larceny (Virginia Code Section 18.2-95), in Case No. CR08-1816-00F, and check forgery (Virginia Code Section 18.2-172), in Case No. CR08-1826-00F, as charged in each indictment, appeared according to the conditions of bond, and came also Jeffrey L. Everhart, her attorney heretofore appointed.

Whereupon, the accused was arraigned and after private consultation with and being advised by her counsel, pleaded GUILTY to each charge, which pleas were tendered by the accused in person. And the Court having made inquiry and being of the opinion that the accused fully understood the nature and effect of her pleas and of the penalties that may be imposed upon her conviction, and of her waiver of trial by jury and of appeal, finding that her pleas were voluntarily and intelligently entered, proceeded to hear and determine these cases without the intervention of a jury as provided by law, and having heard the evidence and argument of counsel, the Court finds the accused guilty of uttering a forged check (Virginia Code Section 18.2-172), in Case No. CR08-1815-00F, grand larceny (Virginia Code Section 18.2-95), in Case No. CR08-1816-00F, and check forgery (Virginia Code Section 18.2-172), in Case No. CR08-1826-00F, as charged in each indictment.

Pursuant to the provisions of Code Section 19.2-298.01, the Court has considered and reviewed the applicable discretionary sentencing guidelines and the guidelines worksheet. The sentencing guidelines worksheet and the written explanation of any departure from the guidelines are ordered filed as a part of the record in these cases.

Whereupon the Court, taking into consideration all of the evidence in this case, and it being demanded of the defendant if anything for herself she had or knew to say why judgment should not be pronounced against her according to law, and nothing being offered or alleged in delay of judgment, it is accordingly the judgment of this Court that the defendant is sentenced in Cases Nos. CR08-1815, 1816, 1826-00F, to confinement in the penitentiary of this

Commonwealth for a term of three (3) years in each case, the execution of which sentence is suspended for ten (10) years, in each case, on condition that she keep the peace and be of good behavior. The Court further Orders that she pay the costs of these cases in the amount of \$1,855.00.

By operation of law, the defendant's privilege to operate a motor vehicle is suspended by the Department of Motor Vehicles effective fifteen days from this date if the fines and costs are not paid pursuant to Virginia Code Section 46.2-395.

The Court certifies that at all times during this proceeding the defendant was present in person and her attorney was likewise present in person and capably represented the defendant, for which services he is allowed an attorney's fee in the amount of \$405.00.

Thereupon, the defendant was allowed to depart.
