**IN RE: SHANI A. HALEY, R.N. APPLICANT**

**CONSENT ORDER**

The Virginia Board of Nursing ("Board") and Shani A. Haley, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Haley's application for licensure to practice professional nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

**FINDINGS OF FACT**

1. Shani A. Haley submitted an application for licensure by examination to practice professional nursing, which was received by the Board on May 20, 2013, declaring Virginia as her primary state of residence.
2. On October 5, 2011, in the General District Court of Colonial Heights, Virginia, Ms. Haley was convicted of misdemeanor embezzlement. She was sentenced to 12 months' incarceration, of which 11 months and 26 days were suspended, placed on 3 years of probation, ordered to complete a shoplifting prevention program and 80 hours of community service, and ordered to pay a fine and costs.
3. Ms. Haley submitted evidence that she has satisfied the terms of her conviction order.

**CONCLUSIONS OF LAW**

1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
2. Ms. Haley otherwise meets the requirements of § 54.1-3017 of the Code.

**CONSENT**

Shani A. Haley, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her application for licensure to practice professional nursing in Virginia.


### **ORDER**

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. The application of Shani A. Haley for licensure by examination as a professional nurse is APPROVED. Upon successful completion of the NCLEX-RN examination, Ms. Haley shall be issued an unrestricted license to practice professional nursing in Virginia.
2. Ms. Haley is hereby REPRIMANDED.
3. Ms. Haley shall maintain a course of conduct in her capacity as a professional nurse commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.


