CONSENT ORDER

The Virginia Board of Nursing ("Board") and Bobbie Bradley, L.P.N., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Bradley's license to practice as a practical nurse in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Bobbie Bradley, L.P.N., was issued License No. 0002-042680, to practice as a practical nurse by the Virginia Board of Nursing on May 23, 1990. Said license is set to expire on January 31, 2015. Her primary state of residence is Virginia.

2. By Consent Order entered October 25, 2012, the Board ordered Ms. Bradley to pay a monetary penalty of two thousand dollars (\$2,000.00) within 30 days of the entry of the Order, but she has failed to do so. The action was based on findings that Ms. Bradley delegated the administration of medication to four staff members who were not licensed to administer medications.

3. The Compliance Case Manager sent Ms. Bradley five delinquency notices between November 27, 2012, and February, 2013. On March 1, 2013, Ms. Bradley informed the Compliance Case Manager that she has not paid the penalty because she has been "going through a lot."

CONCLUSIONS OF LAW

Finding of Fact No. 2 constitutes a violation of Term No. 2 of the Board Order entered October 25, 2012.

CONSENT

Bobbie Bradley, L.P.N., by affixing her signature hereon, agrees to the following:

1. Ms. Bradley has been advised to seek advice of counsel prior to signing this document;
2. Ms. Bradley acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. Ms. Bradley acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. Ms. Bradley waives all such right to an informal conference;
5. Ms. Bradley admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. Ms. Bradley consents to the entry of the following Order affecting her right to practice as a practical nurse in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. Ms. Bradley is hereby REPRIMANDED.
2. License No. 0002-042680 of Bobbie Bradley, L.P.N., is INDEFINITELY SUSPENDED until she complies with Term No. 2 of the Board's Order by remitting payment to the Board of TWO THOUSAND DOLLARS (\$2,000.00).
3. The license will be recorded as suspended and no longer current.
4. This suspension applies to any multistate privilege to practice practical nursing.

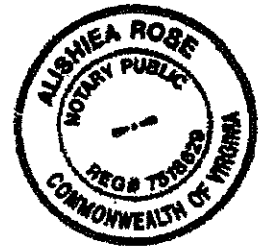
