CONSENT ORDER

The Virginia Board of Nursing ("Board") and Pamela Green, L.P.N., as evidenced by her signature

hereto, enter into the following Consent Order affecting Ms. Green's license to practice practical nursing in

Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Pamela Green, L.P.N., was issued License No. 0002-066797 to practice practical nursing by

the Virginia Board of Nursing on August 4, 2003. Said license is set to expire on April 30, 2015. Ms. Green

also held a certificate to practice as a nurse aide in Virginia that is expired. Her primary state of residence is

Virginia.

2. During the course of her employment with Envoy of Williamsburg, Williamsburg, Virginia,

on October 29, 2012, Ms. Green found Resident A, who suffers from dementia, on the floor and failed to

document or otherwise report the event. A nurse aide had notified Ms. Green that Resident A was on the

floor. Ms. Green later told two nurse aides not to tell anyone Resident A had fallen. The next day Resident

A was diagnosed with a fractured wrist.

3. Envoy of Williamsburg terminated Ms. Green's employment as a result of the incident.

CONCLUSIONS OF LAW

Finding of Fact No. 2 constitutes a violation of § 54.1-3007(2), (5), and (8) of the Code of Virginia (1950), as amended ("Code") and 18 VAC 90-20-300(A)(2)(f) of the Regulations Governing the Practice of Nursing ("Regulations").

CONSENT

Pamela Green, L.P.N., by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusion of Law contained herein and waives her right to contest such Findings of Fact and Conclusion of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her right to practice practical nursing in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. Pamela Green, L.P.N., is hereby REPRIMANDED.

- 2. Ms. Green shall provide the Board with verification that she has completed the following NCSBN online courses within 60 days of the entry of this Order: Ethics of Nursing Practice and Professional Accountability and Legal Liability for Nurses.
- 3. Ms. Green shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
- 4. Any violation of the terms and conditions of this Order or of any law or regulation affecting the practice of nursing in the Commonwealth of Virginia shall constitute grounds for the suspension or revocation of the license of Ms. Green and an administrative proceeding shall be convened to determine whether such license shall be suspended or revoked.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
