CONSENT ORDER

The Virginia Board of Nursing ("Board") and Nirav P. Jani, as evidenced by his signature hereto, enter into the following Consent Order affecting Mr. Jani's application for licensure by endorsement to practice practical nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Nirav P. Jani, L.P.N., was issued License No. LP48886 to practice practical nursing by the Maryland Board of Nursing on April 27, 201,1 with multistate privileges to practice in other Compact states. Said license expired on August 28, 2012, due to his failure to complete the renewal process.
- 2. Mr. Jani submitted an application for license by endorsement to practice practical nursing which was received by the Board on March 22, 2013. Mr. Jani declared Virginia as his primary state of residence.
- 3. On August 5, 2012, Mr. Jani attempted to renew his Maryland license on-line and received a confirmation causing him to believe that the transaction had successfully renewed his license. Subsequently, Mr. Jani found that due to his failure to have a criminal history records check, his Maryland license was not renewed.
- 4. On April 26, 2013, the Maryland Board of Nursing renewed Mr. Jani's license following receipt of his criminal history records check.
- 5. From August 29, 2012, until February 13, 2013, during the course of his employment with Prince William Family Medicine, Manassas, Virginia, Mr. Jani practiced as a practical nurse without a valid license or multistate privilege to do so in Virginia.

CONCLUSIONS OF LAW

- 1. Finding of Fact No. 5 constitutes a violation of §§ 54.1-3007(3) and 54.1-3008(2) of the Code of Virginia (1950), as amended ("Code").
 - 2. Otherwise, Mr. Jani meets the requirements of § § 54.1-3020 and 54.1-3021 of the Code.

CONSENT

Nirav P. Jani, L.P.N., by affixing his signature hereon, agrees to the following:

- 1. He has been advised to seek advice of counsel prior to signing this document;
- 2. He acknowledges that without his consent, no legal action can be taken against him except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. He acknowledges that he has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against him;
 - 4. He waives all such right to an informal conference;
- 5. He admits to the Findings of Fact and Conclusions of Law contained herein and waives his right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. He consents to the entry of the following Order affecting his application for licensure by endorsement to practice practical nursing in Virginia.

<u>ORDER</u>

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The application of Nirav P. Jani for licensure by endorsement to practice practical nursing is APPROVED. Mr. Jani shall be issued an unrestricted to practice as a practical nurse in the Commonwealth.
 - 2. Mr. Jani is hereby REPRIMANDED.
- 3. Mr. Jani shall maintain a course of conduct in his capacity as a practical nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
