Dear Ms. Shetley:

Pursuant to Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), you are hereby given notice that your license to practice as a licensed nurse practitioner in the Commonwealth of Virginia has been mandatorily suspended by the enclosed Order entered June 25, 2013. You are hereby advised that, pursuant to Section 54.1-2409.1 of the Code, any person who practices a profession or occupation after having their license, certificate or privilege to do so suspended shall be guilty of a felony. Please return your license to Jay P. Douglas, Executive Director of the Virginia Board of Nursing, at the above address, immediately upon receipt of this letter.

Section 54.1-2409 of the Code further provides that you may apply to the Board of Nursing ("Board") for reinstatement of your license to practice in the Commonwealth of Virginia, and shall be entitled to a hearing not later than the next regular meeting of the Board after the expiration of sixty days from the receipt of such reinstatement application. You have the following rights, among others: to be represented by legal counsel, to have witnesses subpoenaed on your behalf, to present documentary evidence and to cross-examine adverse witnesses. The reinstatement of your license shall require the affirmative vote of three-fourths of the members present of the Board of Nursing

In accordance with Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), I, Dianne L. Reynolds-Cane, M.D., Director of the Virginia Department of Health Professions, received and acted upon evidence that the South Carolina Board of Nursing accepted the voluntary surrender, in lieu of further disciplinary action, from Crystal Lorraine Shetley, L.N.P., of her license to practice as an advanced registered nurse practitioner in the State of South Carolina by an Agreement of Voluntary Surrender dated May 2, 2013. Should Ms. Shetley seek reinstatement of her license pursuant to Section 54.1-2409 of the Code, she shall be responsible for any fees that may be required for the reinstatement and renewal of her license prior to issuance of her license to resume practice.

I, CRYSTAL LORRAINE SHETLEY, have been informed that I am under investigation for alleged violations of South Carolina laws. I have been further informed that I have the right to <u>VOLUNTARILY SURRENDER</u> my nursing license under Section 40-1-150 of the 1976 Code of Laws of South Carolina, as amended; that I do hereby <u>VOLUNTARILY</u>

<u>SURRENDER</u> my nursing license and ask the South Carolina Board of Nursing to accept said <u>VOLUNTARY SURRENDER</u>. I understand that the voluntary surrender of my nursing license may not be considered as an admission of guilt by the Board, panel, or court or other entity; that the Board may bring charges against me after proper notice; that I have a right to a hearing; and that I have a right to be represented by legal counsel.
