ORDER

Pursuant to §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), a Special Conference Committee ("Committee") of the Virginia Board of Nursing ("Board") met on June 3, 2013, in Henrico County, Virginia, to receive and act upon Sandra Marchitelli's application for reinstatement of her license to practice practical nursing in Virginia, and to inquire into evidence that Ms. Marchitelli may have violated certain laws governing nursing practice. Ms. Marchitelli was present and was not represented by counsel.

Upon consideration of the evidence, the Committee adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Sandra Marchitelli, L.P.N., was issued License No. 0002-017349 to practice practical nursing in the Commonwealth of Virginia on November 28, 1972. Said license expired on January 31, 1981. Ms. Marchitelli was issued License No. 027665 to practice practical nursing in North Carolina on July 2, 1982. Said license was voluntarily surrendered by Ms. Marchitelli on August 1, 1989, as a result of her providing substandard care. Ms. Marchitelli was issued License No. 300489 to practice practical nursing in New York on March 3, 2010. Said license expires on December 31, 2015.
- 2. By letter dated May 7, 2013, the Board of Nursing sent a Notice of Informal Conference ("Notice") to Ms. Marchitelli notifying her that an informal conference would be held on June 3, 2013. The

Notice was sent by certified and first class mail to 469 Cheshire Court, Newport News, Virginia 23602, the address of record on file with the Board of Nursing.

- 3. Ms. Marchitelli submitted an application for reinstatement of her license to practice practical nursing which was received by the Board on November 9, 2012. Ms. Marchitelli declared Virginia as her primary state of residence.
- 4. Ms. Marchitelli provided evidence that she was employed as a practical nurse from April 5, 2010 until December 31, 2012, with BryLin Hospital, Buffalo, New York, which is a psychiatric and substance abuse facility. Ms. Marchitelli provided a copy of her evaluation from BryLin Hospital dated May 5, 2012, which states that Ms. Marchitelli often goes above and beyond a satisfactory rating and is an asset to the facility.

CONCLUSIONS OF LAW

Ms. Marchitelli meets the requirements for reinstatement of her license to practice practical nursing.

ORDER

On the basis of the foregoing, the Committee hereby ORDERS as follows:

- 1. The application of Sandra Marchitelli for reinstatement of her license to practice practical nursing is APPROVED. Ms. Marchitelli shall be issued an unrestricted license to practice as a practical nurse in the Commonwealth.
- 2. Ms. Marchitelli shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.

Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
