#### CONSENT ORDER

The Virginia Board of Nursing ("Board") and Barbara J. Satchell, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Satchell's application for reinstatement of her certificate to practice as a nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

# FINDINGS OF FACT

- 1. Barbara J. Satchell was issued Certificate No. 1401-062214 to practice as a nurse aide by the Virgi0nia Board of Nursing on October 29, 1996. Said certificate expired on October 31, 2010.
- 2. Ms. Satchell submitted an application for reinstatement of her certificate, which was received by the Board on February 25, 2013.
- On February 11, 2008, Ms. Satchell was convicted in the Circuit Court of Northampton 3. County, Virginia, of one count of uttering and one count of obtaining money by false pretenses, both felonies.
  - Ms. Satchell has paid all costs and fees associated with her 2008 convictions. 4.

# CONCLUSIONS OF LAW

- 1. Finding of Fact No. 3 constitutes a violation of § 54.1-3007(4) of the Code.
- Ms. Satchell otherwise meets the requirements for reinstatement of her certificate to practice 2. as a nurse aide.

### CONSENT

Barbara J. Satchell, by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
  - 4. She waives all such right to an informal conference:
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her application for reinstatement of her certificate to practice as a nurse aide in Virginia.

### ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The application of Barbara J. Satchell for reinstatement of her certificate to practice as a nurse aide in the Commonwealth of Virginia is hereby APPROVED.
  - 2. Ms. Satchell is REPRIMANDED.
- 3. Ms. Satchell shall maintain a course of conduct in her capacity as a professional nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
