#### CONSENT ORDER

The Virginia Board of Nursing ("Board") and Courtney L. Wilson, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Wilson's application for certification by examination to practice as a nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

#### FINDINGS OF FACT

- 1. Courtney L. Wilson submitted an application for certification by examination as a nurse aide, which was received by the Board on March 7, 2013.
- 2. On March 22, 2011, Ms. Wilson was convicted in the Lynchburg, Virginia, General District Court, of petit larceny.
  - 3. Ms. Wilson has paid all court costs and fees associated with the conviction.

## CONCLUSIONS OF LAW

The Board concludes that:

- 1. Findings of Fact No. 2 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
  - 2. Ms. Wilson otherwise meets the qualifications of § 54.1-3023 of the Code.

## **CONSENT**

Courtney L. Wilson, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;

- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
  - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her application for certification by examination as a nurse aide in Virginia.

#### ORDER

WHEREFORE, it is hereby ORDERED as follows:

- 1. The application of Courtney L. Wilson for certification by examination as a nurse aide is APPROVED. Upon successful completion of the NNAAP examination, Ms. Wilson shall be issued an unrestricted certificate to practice as a nurse aide in the Commonwealth.
  - 2. Ms. Wilson is hereby REPRIMANDED.
- 3. Ms. Wilson shall maintain a course of conduct in her capacity as a nurse aide commensurate with the requirements of § 54.1-3000 *et seq*. of the Code and the Board of Nursing Regulations.

Pursuant to § 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.
