<u>ORDER</u>

In accordance with §§ 2.2-4019, 2.2-4021 and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), an informal conference was conducted on behalf of the Board of Nursing ("Board") on September 4, 2014 in Henrico County, Virginia. Leslie Wilson, L.P.N. was not present nor was she represented by legal counsel. Jane Elliott, R.N., Ph.D., serving as Agency Subordinate for the Board,

submitted a Recommended Decision for consideration.

On November 19, 2014, a quorum of the Board met to receive and act upon the Recommended Decision of the Agency Subordinate. Ms. Wilson was not present nor was she represented by legal

counsel.

Based upon its review of the Recommended Decision of the Agency Subordinate, the Board makes the following Findings of Fact and Conclusions of Law and issues the following Order.

FINDINGS OF FACT

1. Leslie Wilson, L.P.N. was issued License No. 0002-080547 to practice practical nursing in

Virginia on June 23, 2009. The license is scheduled to expire on May 31, 2016. Her primary state of

residence is Virginia.

2. By letter dated July 30, 2014, the Board of Nursing sent a Notice of Informal Conference

("Notice") to Ms: Wilson notifying her that an informal conference would be held on September 4, 2014.

The Notice was sent by certified and first class mail to 2099 Mob Creek Road, Bedford, Virginia 24523,

the address of record on file with the Board of Nursing. The Notice was also sent to 3688 Peters Creek

Road, Big Island, Virginia 24526, a secondary address. The certified mail receipt for the Notice sent to the

address of record was signed by Ms. Wilson on August 1, 2014. The certified mail receipt for the Notice sent to the secondary address was returned to the Board office unsigned. The Notices sent by first class mail were not returned to the Board office. The Agency Subordinate concluded that adequate notice was provided to Ms. Wilson and the informal conference proceeded in her absence.

- 3. By Term No. 2 of an Order entered June 11, 2013 ("Board's Order"), the Board required Ms. Wilson to provide the Board with verification that she had completed two online NCSBN courses within 60 days of the entry of the Board's Order, or by August 10, 2013. This Order was based on findings that Ms. Wilson had documented administering medications to five residents of an assisted living facility but that she had failed to actually administer the medications.
- 4. Ms. Wilson failed to complete the required courses and provide the Board with evidence that she had done so until February 2014. She did not provide an explanation for her delay in complying with the Board's Order.

## **CONCLUSIONS OF LAW**

Finding of Fact No. 4 constitutes a violation of Term No. 2 of the Board's Order entered June 11, 2013.

## <u>ORDER</u>

WHEREFORE, it is hereby ORDERED as follows:

- 1. Leslie Wilson, L.P.N. is hereby REPRIMANDED.
- 2. Ms. Wilson shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.

Pursuant to § 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public

inspection and copying upon request.

Since Ms. Wilson failed to appear at the informal conference, this Order shall be considered final. Ms. Wilson has the right to appeal this Order directly to the appropriate Virginia circuit court. As provided by Rule 2A:2 of the Supreme Court of Virginia, Ms. Wilson has thirty (30) days from the date of service (the date she actually received this decision or the date it was mailed to her, whichever occurred first) within which to appeal this decision by filing a Notice of Appeal with Jay P. Douglas, M.S.M., R.N., C.S.A.C., F.R.E., Executive Director, Board of Nursing, at Perimeter Center, 9960 Mayland Drive, Suite 300, Richmond, Virginia 23233. In the event that this decision is served by mail, three (3) days are added to that period.
