CONSENT ORDER

The Virginia Board of Nursing ("Board") and Jessica Bean, R.N., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Bean's application for reinstatement of her license to practice as a professional nurse in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Jessica Bean, R.N., was issued License No. 0001-211887 to practice professional by the Virginia Board of Nursing on March 21, 2008. Said license expired on August 31, 2009. Ms. Bean's primary state of residence is Virginia. Ms. Bean currently holds License No. 236853 to practice professional nursing in North Carolina, which expires on August 31, 2013. Ms. Bean previously held License No. 2006011723 to practice professional nursing in Missouri, which expired on April 30, 2011. Ms. Bean previously held License No. 2004021221 to practice practical nursing in Missouri, which expired on May 31, 2006. Ms. Bean's licenses in North Carolina and Missouri have no restrictions upon them, and she has not been subject to any disciplinary action in either state.
- 2. Ms. Bean submitted an application for reinstatement of her license, which was received by the Board on February 28, 2013.
- 3. On her reinstatement application, Ms. Bean disclosed a 2006 Missouri conviction for passing a bad check in the amount of less than \$300.00, a misdemeanor involving moral turpitude.

4. Ms. Bean failed to disclose this conviction on her 2008 application for licensure by endorsement.

CONCLUSIONS OF LAW

- 1. Finding of Fact No. 3 constitutes a violation of § 54.1-3007(4) of the Code.
- 2. Finding of Fact No. 4 constitutes a violation of § 54.1-3007(1) of the Code and 18 VAC 90-20-300(A)(1)(b) of the Regulations Governing the Practice of Nursing.
 - 3. Ms. Bean otherwise meets the requirements for reinstatement of her license.

CONSENT

Jessica M. Bean, by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her application for reinstatement of her license to practice professional nursing in Virginia.

<u>ORDER</u>

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The application of Jessica Bean for reinstatement of her license to practice professional nursing in the Commonwealth of Virginia is hereby APPROVED.
 - 2. Ms. Bean is REPRIMANDED.
- 3. Ms. Bean shall maintain a course of conduct in her capacity as a professional nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
