CONSENT ORDER

Pursuant to Section 5-34-24 the General Laws of the State of Rhode Island, 2008 Reenactment, a complaint was filed with the Board of Nurse Registration and Nursing Education (hereinafter referred to as "Board") charging Patricia Clark, RN, Respondent with a violation of Chapter 5-34 of the General Laws of the State of Rhode Island, 2008 Reenactment.

After consideration by the Investigating Committee of the Board, it was agreed by and between the parties:

1. Respondent is a registered nurse licensed to practice in the State of Rhode Island.
2. That at all pertinent times Respondent was employed at Hebert Nursing Home in Smithfield , Rhode Island.
3. That Respondent failed to report the alleged patient abuse to the Department of Health as required while working as the Director of Nursing.

That the conduct described in paragraph three (3) herein constitutes unprofessional conduct as defined in Section 5-34-24 (6) (iii) and the Rules and Regulations promulgated there under.

The parties agree as follows:


1. Respondent is a registered nurse, license number RN30673, and able to conduct business under and by virtue of the laws of the State of Rhode Island.
2. Respondent admits to the jurisdiction of the Board.


3. Respondent has read this Consent Order and understands that it is a proposal of the Board and subject to final ratification by the Board. This Consent Order and the contents thereof are not binding on Respondent until final ratification by the Board.

4. Respondent hereby acknowledges and waives:

- a) The right to appear personally or by counsel or both before the Board;
 - b) The right to produce witnesses and evidence in her behalf at a hearing;
 - c) The right to cross-examine witnesses;
 - d) The right to have subpoenas issued by the Board;
 - e) The right to further procedural steps except for those specifically contained herein;
 - f) Any and all rights of appeal of this Consent Order;
 - g) Any objection to the fact that this Consent Order will be presented to the Board for consideration and review;
 - h) Any objection to the fact that it will be necessary for the board to become acquainted with all evidence pertaining to this matter in order to adequately review this Consent Order;
 - i) Any objection to the fact that the Board reviewing this Consent Order may be the same as the Hearing Committee presiding over this matter should it later be brought to an administrative proceeding;
- Any objection to the fact that potential bias against the Respondent may occur as a result of the presentation of this Consent Order to the Board. The signing of this Consent Order is for settlement purposes only.

4. This Consent Order shall become part of the public record of this proceeding once it is accepted by all parties and accepted by the Board.
5. Acceptance by the Respondent and approval by the Board of this Consent Order constitutes an admission of the facts contained herein.
6. Respondent voluntarily agrees to accept the sanction of a Reprimand.
7. That the Respondent shall, on or before August 31, 2012, present evidence of enrollment and satisfactory completion of continuing education courses in "Professional Accountability & Legal Liability for Nurses, Ethics of Nursing and Assessment and Critical Thinking Skills." In addition, the Respondent shall review the Regulations pertaining to the reporting of resident abuse and neglect R23-17-NF and the Nurse Practice Act. Both can be found on the Health website www.health.ri.gov.
8. The aforementioned courses can be found at www.ncsbn.org. Once you are on the NCSBN home page scroll to the bottom of the page where you will see 13 icons. Click on ncsbn learning extension (2nd row 4th icon from left to right). Then click on NURSES which will bring you to the course titles. Click on sign up and register for the course.
9. That should Respondent fail to comply with the laws and regulations governing the practice of nursing and/or fail to comply with the terms of this Consent Order, her license as a registered nurse shall be subjected to suspension or other appropriate disciplinary

action.
